



Official Notice of General Election: Boulder County, Colorado



Election Day – Tuesday, November 8, 2016
Voting begins October 17

GENERAL ELECTION INFORMATION

Elections in Colorado are conducted by mail ballot with Voter Service and Polling Centers available for those who would like additional assistance or prefer to vote in person. See below for a list of locations and hours/days of operation.

For this General Election, ballots will be mailed to all active registered voters the week of October 17. Ballots must be returned to the Clerk and Recorder no later than 7 p.m. on Election Day (Tuesday, November 8) in order for your votes to be counted. Voters can return their ballot by mail or by dropping it off at any designated ballot drop-off location or Voter Service and Polling Center. Ballots received after 7 p.m. on Election Day will not be counted. Postmarks do not count as a received date.

After returning a ballot, voters can verify that their ballot was received by visiting www.BoulderCountyVotes.org. Additionally, voters may also sign up with Boulder County Votes Ballot Track in order to receive alerts about their mail ballot. Voters can sign up for this service at any time of year.

If you need to register or update your voter registration, please do so at www.GoVoteColorado.com. The Boulder County Elections Division recommends all voters review their information to ensure their mailing address is correct.

If you make a mistake, damage, or lose your ballot, you may request a replacement ballot by emailing Vote@BoulderCountyVotes.org, calling 303-413-7740, or by visiting a Voter Service and Polling Center.



Voter Service and Polling Centers – Centers have staggered open dates. See below for schedule of openings and days/hours available. Services include:
