
BOULDER COUNTY FLOODPLAIN REMAPPING NEWSLETTER 4th Edition – Winter 2017


In this edition of the Floodplain Remapping Project newsletter, we provide an update on the Colorado Water Conservation Board's (CWCB) floodplain remapping program (CHAMP) and Boulder County's efforts to provide online access to this information. We also highlight the process happening this spring to adopt these new maps and related floodplain development code into the county's regulatory framework.

Colorado Hazard Mapping Program (CHAMP) Update

Since December, Boulder County has been hosting a series of reach-specific public meetings to provide landowners throughout unincorporated Boulder County the opportunity to review and comment on draft floodplain data on Phase I stream reaches (see map below) near their properties. Over 100 residents attended these meetings and many more have used our online comment form to provide feedback. We appreciate the input provided so far. Boulder County encourages you to attend a follow-up meeting where we will provide maps from each stream reach within this phase of study for public review.

A website has been established for the purpose of viewing draft maps areas as data becomes available. Comments can be attached directly to specific areas on the online map and the county's Floodplain Management Team will work to answer questions and provide clarification as comments are received. Users can also change the map style, turn layers on and off, and access other online resources relevant to remapping.

Ultimately, all landowner feedback received during this map review period will be submitted to the CHAMP team for consideration prior to their submitting map data to

FEMA for official review. Additional input will be taken during a 90-day FEMA appeals period later in 2017. View the maps by visiting the county's **Floodplain Remapping Project website**.


Upcoming Adoption of Maps as Boulder County Floodplain

Boulder County is a high risk area for flooding hazards. In order to mitigate risk, the county is working to ensure that new floodplain data is accurate and is the best available for managing floodplain development to ensure health and safety of Boulder County residents and property. The adoption process includes zoning amendments to the Floodplain Overlay District and related code language clarification.

Expected next steps include:

- A Planning Commission public hearing will take place to propose map adoption and related zoning & code amendments (likely April 2017).
- Based on the Planning Commission recommendation, it will go to the Board of County Commissioners ('BOCC') for public hearing.
- If approved by the BOCC, the new map data will be incorporated into the Floodplain Overlay District as a part of the Boulder County Floodplain.
