2012 Primary Post-Election Audit Board Statement

July 9, 2012

In accordance with C.R.S. 1-7-514, the 2012 Boulder County Primary Post-Election Audit was completed on July 3, 2012. The audit included a manual verification of 5,239 ballot contests and identified two differences between the manual count and machine count. Both were attributed to human error. A voter making an incomplete mark accounted for one of the differences. The other resulted from a difference in the resolution of voter intent between the resolution and audit teams.

Statistical analysis was completed on all contest outcomes to include the impact of difference. No impact was found in any contest outcome and the audit board does not recommend any recounts for the 2012 Primary Election held in Boulder County on Tuesday, June 26, 2012.

2012 Primary Post-Election Audit Summary of Differences

For the 2012 Primary Post-Election Audit, all four contested races were selected for the audit and spanned 30 scan station MBB batches selected by the Canvass Board. A total of 5,239 ballot contests were manually verified in the audit. All eight election scan stations were included.

Out of the 5,239 ballot contests audited, there were a total of two differences found.

One of the differences identified between the audit team count and machine count was due to an incomplete mark in the target area, counted as a vote for Elise Jones in the County Commissioner District 1 race.

The second difference identified was a difference of opinion in the resolution of voter intent between the resolution team on election night and the post-election audit teams. This difference was in the Representative Congressional District 2 race; where the audit teams resolved the contest as an Overvote while the resolution judges resolved it as a vote for Eric Weissmann.

Statistical analysis was completed on all contest outcomes to include the impact of the differences. No impact was found in any contest outcome that warrants escalation or a recommendation for recount.



July 9, 2012


In accordance with C.R.S. 1-7-514, the 2012 Boulder County Primary Post-Election Audit was completed on July 3, 2012. The audit included a manual verification of 5,239 ballot contests and identified two differences between the manual count and machine count. Both were attributed to human error. A voter making an incomplete mark accounted for one of the differences. The other resulted from a difference in the resolution of voter intent between the resolution and audit teams.


Statistical analysis was completed on all contest outcomes to include the impact of difference. No impact was found in any contest outcome and the audit board does not recommend any recounts for the 2012 Primary Election held in Boulder County on Tuesday, June 26, 2012.


