The following information is to be used to resolve issues that arise from the selection of devices and races by the Secretary of State's office:

If a device was identified as being available for use but did not have any votes cast on it, please indicate the status as "NO VOTES" in the field for Device Count and Manual/Hand Count.

If backup equipment was selected for the audit, contact the Secretary of State's Office.

If a voter service and polling center scanner or DRE has votes on it, but any of the races selected for audit do not appear on the device, contact the Secretary of State's Office.

If a central count scanner has votes on it, but the races selected for audit do not appear in the ballots chosen by the canvass board, then the canvass board must continue to randomly select ballots until all races can be audited.

The report must be signed by the canvass board members and the designated election official. E-mail the completed and signed report to <u>voting.systems@sos.state.co.us</u> no later than 5:00 p.m. on November 21st, 2014.


Boulder County 2014 General Election Reconciliation Report

November 21, 2014

Overview

The election reconciliation process is one of the steps required by Colorado state statutes and election rules in order for election results to be certified by the Canvass Board. Statute CRS 1-10-101.5 specifically requires reconciliation of ballots cast in order to ensure that the number of votes counted <= number of ballots cast <= number of eligible voters. SOS Rule 10 states that election details must be preserved, requiring tracking of issued ballots as well as voted ballots as they pass through the election processes.

This report will present both summary data regarding the overall election processes, as well as a detailed accounting of ballots on a precinct-by-precinct basis. A high-level view of the election processes can be seen below:



The reconciliation process primarily focuses on the distribution and reception of ballots, through the assignment of voter credit. Boulder County's audit, the subject of a separate process and report, is the quality assurance procedure that checks the accuracy of the machine tally results.

Statutory Requirement

As mentioned above, Statute CRS 1-10-101 requires that the Canvass Board and reconciliation process ensure that the number of votes counted <= number of ballots cast <= number of eligible voters. For this election, these numbers are as follows:


A total of 10,206 ballots were returned to the county by the USPS as undeliverable.



Ballot Distribution

Mail Ballots

Per Colorado House Bill 1303 which was passed in 2013, ballots are automatically sent to all eligible voters for every election. Eligible voters are the subset of voters that are active, registered in the county by Election Day, reside in one of the jurisdictions on the ballot and are 18 years old or older on Election Day. The diagram below is an overview of the process of mailing ballots.



We use a print/mailing vendor for most of the Mail ballots. We provide the vendor with ballot images and addressing information some weeks before ballots are to be mailed. However, during these weeks we receive and process numerous registration changes, some of which void ballots being processed by the vendor. When possible we attempt to find and secure those voided ballots. For this election we pulled voids 1 time, securing 2,905 voided ballots and reducing the number of mail-pieces managed by the vendor. In addition, 12 ballots were pulled for the purposes of hand-delivery to Health Care Facilities (HCFs), and the vendor returned 46 additional ballots that were put in the mail. The vendor hand-off to the Post Office reflects these numbers. Final totals show a difference of 5 fewer ballots reported being mailed by the vendor than expected by our counts. The discrepancy may be related to the postage calculation process for the bulk ballot mailing, which is calculated by the weight of trays delivered rather than by envelope count.



Ballot Reception

Mail-in ballots are received either through the Post Office or drop-off ballot boxes from Voter Service and Polling Centers and drive-by drop-off locations. These ballots are validated by Election Workers and either accepted or rejected, depending upon the envelope signature, and recorded accordingly in SCORE. Letters are sent to the voters with a rejected signature, allowing them to come in and "cure" the envelope. Only the ballots associated with accepted envelopes proceed through the process to scanning, resolution, and tallying.

Voted paper ballots from Voter Service and Polling Center (VSPC) locations arrive in separate ballot boxes from the mail-in ballots. Because the voters were already recorded in SCORE and had their signature verified at the VSPC locations, these ballots go directly to scanning, resolution, and tallying after being counted.



Attachment 2 provides an accounting of ballots received. The left hand portion of Attachment 2 shows the ballots received in SCORE by vote method.

Tally Accounting

Once the ballots are scanned, resolved and tallied, the number of votes counted should equal the number of accepted ballots in SCORE.

Election Audit

The election audit confirms the ballots cast and the vote count. Randomly selected contests and randomly selected ballots are manually tallied and compared with the machine count of the same ballots. The Audit results are summarized in a separate report.

Dear Secretary Gessler:

The undersigned have been appointed by the county chairpersons of our respective political parties and represent a majority of the members of the Boulder County Canvass Board for the 2014 General Election.

The County Clerk and Recorder of Boulder County has represented to us that the number of ballots counted in the 2014 General Election was 144,333 and that the number of ballots cast in that election was 145,759. Based solely on these representations, we can certify that the number of ballots counted in that election does not exceed the number of ballots cast in that election.

The County Clerk and Recorder of Boulder County has further represented to us the number of ballots cast and number of electors in each precinct of Boulder County during the 2014 General Election. Based solely on these representations, we can certify that the number of ballots cast in each precinct of Boulder County does not exceed the number of registered electors in each such precinct.

However, based on the limited information provided to us by the Boulder County Clerk and Recorder, we cannot confirm the accuracy of the number of votes counted, or the number of ballots cast, in Boulder County during the 2014 General Election. Further, we cannot confirm the accuracy of the number of ballots cast in each precinct of Boulder County nor the accuracy of the number of registered electors in each precinct during the 2014 General Election. Therefore, we cannot certify the Abstract of Votes Cast.

The gross count of "all eligible electors, all voters, all cast ballots, and all counted ballots" described above does not provide the transparency required for canvassing the election. For example, the gross number of eligible electors is useful for statewide contests, but not all contests are statewide and not all electors are eligible to vote in all contests.

The files and records provided to the board by the Clerk and Recorder contain some of the data that would be needed to complete a canvass, but there is insufficient time for the board to have the data transcribed from the various reports into an electronic format for evaluation.

In this and in previous elections, the canvass board has requested specific data be timely made available to the board in standard file types (EXCEL, CSV, ACCESS). Our requests have not as yet been fulfilled. We cannot even assure the public that the internal workings of the Hart Intercivic vote-counting system operated correctly during the election, because the audit performed took place on rescanned ballots. No data from the actual election was audited, unlike the process in Boulder County's famous risk-limiting audit. The risk-limiting audit would have increased our confidence in the machined parts of the election, but only the basic audit of rescanned ballots was performed by Boulder County in this election.

In addition, beyond the purely numerical data created during the 2014 General Election in Boulder County, we are aware of underlying fundamental problems that exist and cause us to have no confidence that the numbers of "voters who voted" (Rule 10.3.2(a)(3)) by mail are actually eligible in their jurisdiction. The reason is simple: The signature verification process is bogus, as shown by two facts:

- (1) In the early days of the mail ballot reception, the election judges were improperly appointed, yet they accepted signatures on a material number of ballots.
- (2) Throughout the election, the watchers were prevented by the fast signature analysis imposed by the Clerk and Recorder from exercising their rights (C.R.S. 1-7-108) to "witness and verify," to "challenge ineligible electors" (by virtue of a mismatched signature according to the Secretary of State's signature-matching codes), and to "assist in the correction of discrepancies."

Thus the checks and balances envisioned in statute and rule have been largely absent.

Finally, Rule 10.1.3(a) requires a reconciliation in the polling location of ballots and voters who voted and subsequent parts to Rule 10.1.3 require other reconciliation steps in the polling location, presumably under the eyes of watchers. That process was deferred by Boulder County until ballots arrived at the central counting place. There is no chain of custody for those ballots for significant periods, and their provenance cannot be guaranteed.

It is incumbent on the Canvass Board to address voter eligibility where failures involving obstructed watchers and improperly appointed judges make the eligibility requirement's fulfilment uncertain at best. We raise this issue because the watchers' and election judges' function that was supposed to be carried out was thwarted by Boulder County's policies and actions, as detailed above.

Our duty to the electorate cannot be met by November 21st, so we are duty bound to not certify this election.

Estimation of Error Rate and Risks for the Boulder County 2014 General Election

Summary

We are not using a risk-limited audit, but we can estimate the error rate and the risks. The risk is the probability that a full, hand tally would disagree with reported outcome (Linderman and Stark, 2012). Our procedure differs from a risk-limited audit, because there is no provision for auditing a larger sample (up to a full hand recount), if we cannot demonstrate that the risk is below the specified limit. However, in this case, the consequence of not using a risk-limited audit is that we audited more ballots than was necessary.

I am 95% confident that the error rate, estimated from the audit, is less than 0.0003304016 (three hundredths of one percent), compared the result that would be obtained from a complete hand recount. I also estimated the one-tail upper 95% confidence bounds on the number of erroneous votes in each contest in Boulder County, excluding contests with more than one winner. A one-tailed bound is used, because we are not concerned if the error rate is too small. If that bound is larger than the margin between the winner and his/her closest competitor, then we must question the election result, assuming the worst case that all the errors should have been counted for the loser. Fortunately, it was never even close, so we can have confidence in the election results are the same as would result from a full hand count, based on the audit. There are, of course, other issues that would not be revealed by a full hand count.

Methods

The Secretary of State specified the scanner and contests to be audited. The Canvass Board selected 24 batches of 25 ballots to be audited and observed the hand count of the selected ballots. The selected ballots were scanned again and the counts compared with the hand counts. The counts wore provided by the Clerk as a spreadsheet. The first task is to reorganize the data into a form appropriate for the analysis. I used the R statistical system (R Core Team, 2014).

The output was a table (result.xlsx) like:

The next step was to estimate the error rate (equal to the probability of error) using logistic regression (Maindonald and Braum, 2010, page 247), which analyzes the loget, the logarithm of the odds ratio [p/(1-p)], where p is the probability of an error] using the binomial distribution, not the normal distribution. A one-tailed confidence bound is used, because we are not concerned if the error rate is too small.

I also estimated the upper 95% confidence bound on the number of erroneous votes for each contest by multiplying the upper bound on the error rate (0.0003304016) by the number of votes for the top two competitors. The number of votes is known without sampling error, so there is no variance associated with it.

Results

I am 95% confident that the error rate, estimated from the audit, is less than 0.0003304016 (three hundredths of one percent), compared the result that would be obtained from a complete hand recount. I also estimated the upper one-tail 95% confidence bound on the number of erroneous votes in each contest in Boulder County, excluding contests with more than one winner (Table 1). If that bound is larger than the margin of victory between the winner and his/her closest competitor, then we must question the election result, assuming the worst case that all the errors should have been counted for the loser. Fortunately, it was never even close, so we can have confidence in the election results are the same as would result from a full hand count, based on the audit. There are, of course, other issues that would not be revealed by a full hand count.

Table 1. Margin of Victory for 2014 Boulder County Election Contests and 95% Upper, One-Tailed Confidence Bounds On Numbers Of Errors, Based On the Audit Of 24 Batches Of 25 Ballots. One tail was used because we are not concerned if the error rate is too small. Assuming the worst case that all errors are counted for the looser, we would be concerned that a complete, hand recount would give a different result than the one reported , if the error bound is greater than the margin of victory.

Boulder County 2014 Election Final Results Available Online

Friday, November 21, 2014

Boulder County, Colo. – The final results from Boulder County's 2014 General Election are available now at BoulderCountyVotes.org. Additionally, the final Statement of Vote, a document that shows precinct-by-precinct results for every candidate and issue on the Boulder County ballots this year, will be forwarded to the Colorado Secretary of State's office to become part of the official statewide election record and is available now online.

Earlier this week, elections staff completed the 2014 election audit, a post-election quality assurance test that ensures the accuracy of the machine tally of votes. Boulder County used the state prescribed audit process which randomly selects the scanning systems, the electronic machines and the contests which to audit. Ballots are pulled and rescanned and compared to a manual count of the same ballots. Any discrepancy is investigated. A final report is issued to the Boulder County Canvass Board for verification prior to election certification.

Despite the fact that there were no documented discrepancies found in the audit or reconciliation that impacted the outcome of any contest, the Boulder County Canvass Board voted in a 4-to-3 decision to not certify the election. This is a follow through on their pre-election threat to not certify the election. Despite this pre-calculated political action, the Boulder County Elections Division anticipates that the Colorado Secretary of State's office will accept the results of the election as they did after both the 2012 General Election and 2014 Primary Election when similar political action was taken by a Canvass Board (see below for background details).

In regard to these actions, Boulder County Clerk and Recorder Hillary Hall had the following to say, "The Canvass Board's decision not to certify is purely political, without basis and out of line with their role as defined by Colorado law. Our election vote reconciliation and audit show that the Boulder County election results are accurate. The Board members who chose not to certify are doing so as they simply do not like mail ballots or the process of how elections are conducted in Colorado. If they had their way, they would require everyone to vote on one day and show an ID with no exception."

Hall continued, "The election judges and our staff did an outstanding job conducting the 2014 General Election. The results show our new election model is working. Colorado had the 4th highest turnout in the nation. The actions of this Canvass Board in no way diminish everyone's hard work. It is unfortunate and frankly a disservice to the voters of Boulder County that once again the Canvass Board chose to operate outside the boundaries of their duties as outlined in law and rule. As has occurred in the last two elections, we anticipate that after the Secretary of State reviews the material, the election will be certified."

By Secretary of State Rule, if nothing found in the audit or reconciliation of the election impacts the outcome of the election, the results must be certified. There were no documented discrepancies found in the audit or the reconciliation that impacted the outcome of any contest.

Additional Background Information:

Canvass board's role in an election: The canvass board's role is to reconcile the number of ballots counted to the number of ballots cast, and to ensure that the number of ballots cast does not exceed the total amount of voters in the county. They are then requested to certify the official abstract of votes.

Composition of the canvass board: Statute states that the canvass board must represent all major parties within the state of Colorado equally. Colorado currently has three major parties: American Constitution, Democratic and Republican. There are two members from each party, in addition to the Clerk and Recorder. As of October 31, in

Boulder County, the Republican Party represents 46,316 active and inactive voters, the Democratic Party represents 101,259 active and inactive voters, and the American Constitution Party represents 313 active and inactive voters.

Appointment to the canvass board: Each county chair is responsible for appointing two members to the canvass board no later than 15 days prior to the election.

Past Certifications: Many of the individuals involved in this fall's non-certification, and in both the Primary 2014 and 2012 non-certification, simply disagree with the way the canvass should be conducted. They have tried for years to get the courts or the legislature to change the way election canvass boards conduct their business, but have been unsuccessful in their attempts. In Boulder County, like every other clerk office, we simply follow election law when conducting our canvass.

Clerk Hall Informs Candidates, Jurisdictions 2014 Election Results are Final

Boulder County, Colo. – Boulder County Clerk and Recorder Hillary Hall notified the coordinating entities who participated in the Boulder County election that the results for the 2014 General Election are final and has issued certificates of election to all county candidates who received a majority vote.

To finalize the election, as stated by law, the Boulder County Clerk prepared and made available to the public a statement of the total number of votes cast in the election for each candidate and for and against each ballot issue.

Last week, Clerk Hall received word that the Secretary of State's office accepted the official statewide abstract of votes cast for state races and issues. "I had hoped the Secretary's decision would have persuaded our canvass board to certify the local results, but that has not happened," stated Clerk Hall. "We still hope that they will go ahead and do so, but, in the meantime, we had to move forward. Four canvass board members will not be allowed to hold the will of the Boulder County voters hostage."

Although some have raised questions about the effect of the canvass board's prior decision not to certify, Clerk Hall says the election results stand. "The canvass board's decision not to certify the county's abstract of votes cast does not nullify the election of county candidates or decisions on county and local ballot issues," remarked Hall. "If that were the case, it would mean that four partisan members appointed by parties whose candidates received only a small percentage of the votes in Boulder County could override the will of 144,405 voters."

Because the margin of victory was so large in all of the races and ballot issues involved, no recount was triggered or requested. At this point, challenges to the election of candidates to office or the result of a ballot issue election are allowed only in narrow circumstances, such as fraud or corruption that could change the result of the election. These types of issues could only be decided by a judge – not the canvass board. Additionally, Boulder County's election had no documented discrepancies in the audit or the reconciliation that impacted the outcome of any contest. As a result, the canvass board should have certified.

Additional Background Information:

Canvass board's role in an election: The canvass board's role is to reconcile the number of ballots counted to number of ballots cast, and to ensure that the number of ballots cast does not exceed the total amount of voters in the county. They are then requested to certify the official abstract of votes.

Composition of the canvass board: The canvass board is composed of two members from each of the "major" political parties plus the Clerk. In the 2010 gubernatorial race, candidate Tom

Tancredo of the American Constitution Party received more than 10% of the vote statewide, the American Constitution Party (ACN) earned "major" party status until the next gubernatorial election, this year. Thus, even though the ACN Party only represents approximately 300 voters in Boulder County, they have had two party representatives (out of six) on the canvass board since 2010 (this will no longer be the case after this year as there was no ACN candidate that received 10% of the vote this fall).

Appointment to the canvass board: Each county chair is responsible for appointing two members to the canvass board no later than 15 days prior to the election.

2014 Canvass Board Vote: This year, the canvass board signed off on the election audit, which tests the election's vote tallying systems and processes to ensure accuracy, but in a 4-to-3 decision voted to not certify the election results. This was in spite the fact that there were no significant discrepancies in the audit or in the reconciliation reports.

Secretary of State Rule Change: After the Primary Election, there was a Secretary of State rule change during the August rule revision period. There was previously an election rule allowing a county clerk to certify local election results when the canvass board failed to certify. This provision was deleted. Nothing in Colorado law states that a canvass board's decision not to certify the county's abstract of votes nullifies the election of county candidates or decisions on county or local ballot issues.
