5. On a different topic, since 2003, the number of elk on Rabbit Mountain County Open Space land, located between Longmont and Lyons, have increased from 25 to over 270, a ten-fold increase. Officials in both Boulder County Open Space and the Colorado Parks and Wildlife believe that the size of the elk herd has become way too large for its surroundings. The elk have developed use patterns where they spend the days on Rabbit Mountain and move to private lands at night to feed on crops. With few natural predators, this elk herd has stopped migrating, they are reproducing more rapidly and causing extensive damage to the highly diverse native plants and wildlife habitat of Rabbit Mountain. Additionally, they are causing damage to neighboring residential fences, landscaping, and agricultural crops. In addition, human-elk conflicts in the surrounding area are also on the rise. Methodology

2017 Boulder County June Issues Survey was conducted on behalf of Boulder County by Drake Research & Strategy, Inc., a public opinion research firm in Boulder, Colorado. The results of this survey are based upon 605 telephone interviews conducted among active voters residing in Boulder County. Drake Research purchased a sample of telephone numbers, and a supplemental list of cell phone numbers, of active County registered voters, which was then randomly sampled. Quotas were established to obtain appropriate representation for gender, geography, political party and for age. Interviews were conducted from May 31 to June 7, 2017. A random sample of 605 has a worst-case 95% confidence interval of plus or minus 4.0% about any one reported percentage.
