

# PUBLIC NOTICE OF SPECIAL ELECTION FOR WARD I **CITY OF LONGMONT, COLORADO BOULDER AND WELD COUNTIES, COLORADO** TO BE HELD **TUESDAY, FEBRUARY 27, 2018**

Pursuant to Section 1-5-205(1) and 1-1-104(34) of the Colorado Uniform Election Code PUBLIC NOTICE IS HEREBY GIVEN in the Counties of Boulder and Weld and the State of Colorado, that the City of Longmont will hold a special municipal election for Ward I on Tuesday, February 27, 2018.

The election is being conducted as a mail ballot election in Boulder and Weld Counties by the City of Longmont, which has contracted with the Boulder County Clerk and Recorder to conduct the election in both Boulder and Weld Counties as a special election.

Ballots will be mailed to all active registered voters in Ward I the week of February 5, 2018. Ballots must be returned to the Boulder County Clerk and Recorder no later than 7 p.m. on Election Day (Tuesday, February 27) in order for your vote to be counted. Voters can return their ballot by mail or by dropping it off at any designated ballot drop-off location or Voter Service and Polling Center. Ballots received after 7 p.m. on Election Day will not be counted. Postmarks do not count as a received date.

At the election, the eligible electors of Ward I of the City of Longmont will vote on the following office and candidates:

#### City Council Ward 1 (vote for one) Russ Lyman Tim Waters Joshua Goldberg

After returning a ballot, voters can verify that their ballot was received by visiting www.BoulderCountyVotes.org. Additionally, voters may also sign up with Boulder County Votes Ballot Track in order to receive alerts about their mail ballot. Voters can sign up at any time of year.

If you need to register or update your voter registration, please do so at www.GoVoteColorado.com. The City of Longmont City Clerk and the Boulder County Clerk and Recorder recommend all voters review their information to ensure the mailing address is correct. If you make a mistake or damage or lose your ballot, you may request a replacement ballot by emailing Vote@BoulderCountyVotes.org, calling 303-413-7740, or visiting the Voter Service and Polling Center.
