II. LCC Member Updates

- a. <u>Angel Bond</u> thanked LCC Member for taking the Social Media Inventory survey. The Advocacy Working Group will use the responses to create a one-page social media action plan to raise awareness of transportation as a basic need in Boulder County.
- b. Outreach to Decision Makers:
 - **i.** March 31: Lisa Bitzer and Christina Balmaceda attended City of Longmont Coffee with Council to discuss the importance of transportation and the LCC.
 - **ii.** April 11: <u>RTD District O Telephone Town Hall</u>: LCC was encouraged to sign up for the RTD Telephone Town Hall and discuss the importance of the proposed Low-Income Pass Program.
 - **iii.** April 13: CDOT Transit Town Hall Friday, 9-12pm, 4201 E. Arkansas Ave; Angel Bond is attending and offered to carpool with anyone else interested in attending.
 - **iv.** <u>VOLUNTEER NEEDED</u>: April 21: <u>Croissants with Council, Lafayette</u>; The LCC needs someone to volunteer to attend this event to discuss the importance of transportation and the LCC.

v. <u>VOLUNTEER NEEDED</u>: April 21: <u>Walkin' and Talkin' with Mayor Muckle</u>, <u>Louisville</u>. The LCC needs someone to volunteer to attend this event to discuss the importance of transportation and the LCC.

c. Legislature:

- **i.** SB18-2014 (RTD): The bill prohibits the regional transportation district from offering new discount fare or incentive programs adopted after the effective date of the bill without prior legislative approval. The LCC is opposed to this bill. It looks like the bill will die due to lack of support, but if it moves forward the LCC will decide on the most appropriate advocacy strategy.
- ii. <u>HB18-1321 (Medicaid NEMT)</u>: The bill requires the department of health care policy and financing (department) to create and implement a method for meeting urgent transportation needs within the existing nonemergency medical transportation benefit under the medical assistance program. Michele Waite noted that any expansion of NEMT services should also be accompanied by increased funding as the current reimbursement rates do not cover the full cost of a trip. The LCC also discussed the need to address NEMT reimbursement fee parity between commercial and nonprofit providers. Fact sheet attached.

III. Recruiting and Managing Volunteers

a. Mary Eldred gave a presentation on the Justice System Volunteer Program, which recruits volunteers to work with at-risk youth, jail inmate clients, victims of crime, and youth in detention. Due to the vulnerability of the people the program works with, it is imperative to have a rigorous volunteer vetting process. The Justice System Volunteer Program posts volunteer opportunities online through sites, such as volunteermatch.org, volunteer.unitedwayfoothills.org, and on the Boulder County website. They have an extensive application process and conduct a full background check using the FBI database, in addition to conducting in-person interviews to ensure the volunteer is a good match for the program requirements. The program encourages volunteers to practice self-care to avoid compassion fatigue as a result of the difficult cases they are working with. The program has approx. 120 volunteers, many of whom work 2hr a week and are instrumental to the success of the program. Annually volunteer hours are valued at approx. \$317,000 in-kind hours. IV. Ride Together by Faye Estes & Valerie Robson

a. Ride Together is a partnership between the faith-based community, LYFT and Douglas County to provide transportation assistance to older adults, low-income families, single parents, people with disabilities and others in Douglas County. The idea arose as a way to meet the transportation challenges of the Winter Shelter Program for homeless families. They created a Transit Community Fund, to which volunteer drivers donate their proceeds to fund trips for clients, who can take a ride from a corporate or volunteer driver. If the clients use a corporate driver, that trip is paid for out of the Transit Community Fund, eliminating the need to coordinate volunteer driver availability with the client's scheduling needs. After the pilot period and program evaluation, they will make changes to the program mechanics to ensure long-term sustainability. For questions




- V. Volunteer Driver Program Panel Discussion: Volunteer driver programs fill an important gap in the transportation network by providing trips that are beyond the geographic and/or hours of service for traditional transportation networks. Volunteers are always in demand that the LCC is dedicated to promoting volunteer recruitment efforts either through social media or posting flyers for volunteer driver programs.
 - a. *Boulder County CareConnect*: Regis Lindsay discussed their volunteer driver program, which provides transportation to medical appointments outside of Boulder County and transportation for veterans to VA facilities as far away as Cheyenne, WY. BCCC gets the majority of their volunteers from tabling events and provides mileage reimbursement for volunteers.
 - b. Faith in Action: <u>Jan Davies</u> discussed their volunteer transportation to community events and appointments with doctors and hospitals in private automobiles that are not wheelchair equipped. FIA gets the majority of their volunteers by working with several faith-based organizations in Boulder County. Their services are free but drivers may or may not accept money for gas.
 - c. *Via Mobility Services*: <u>Lisa Bitzer</u> discussed their volunteer driver program and Family and Friends mileage reimbursement program. Via uses volunteer drivers for trips that their paratransit vehicles cannot make, but clients can request volunteer drivers. If Via cannot provide a ride with paratransit or volunteer drivers, they will offer mileage reimbursement to the client through the Friends + Family Program for mileage expenses of family members, friends or neighbors who provide a qualifying trip. Via gets most of its volunteers through word of mouth. Volunteers provide trips in Via owned vehicles.
 - d. *DRMAC Rides*: Chris Shipps discussed DRMAC pilot volunteer driver program in Arapahoe County to help drive young adults with intellectual and developmental disabilities (I/DD) (18-26 years old) who cannot drive themselves maintain their independence by providing them with rides to various appointments and social events. Trips are provided 5-9pm, which is beyond the service hours of traditional human services transportation providers. DRMAC Rides gets most of its volunteers from families who have children with I/DD and provides mileage reimbursement for volunteers.





Please Support HB18-1321 Efficient Administration of Non-Emergency Medical Transportation!

What the bill does?

The bill requires the Department of Health Care Policy and Financing (HCPF) to create and implement a method for meeting urgent transportation needs within the existing nonemergency medical transportation benefit under the medical assistance program. This method would be available statewide for those who qualify for the benefit.


Why the bill is needed?

- Medicaid contracts Non-Emergency Medical Transport (NEMT), through the metro area transportation broker, requires a 24-hour notice for transporting patients. This notice is not always possible in instances where there is not a scheduled discharge time, or the driver misses the patient pickup.
- Short notice non-medical transportation requests like in patient hospital discharges can take 3-7 hours to fill.
- This would allow the medical service provider and facility to access a list of approved providers
 who can meet the urgent transportation needs such as hospital discharges and other uses as
 determined by the Department.
- Ensuring that patients are transported in a timely manner reduces health care costs and protects the patient from any unnecessary delay in care.
- The list of approved transportation providers would be required to have obtained the necessary background checks, drug tests, training and vehicle inspections as required by the state department.

Via AT A GLANCE

Via Paratransit

Via's Paratransit program provides wheelchair accessible, door-through-door transportation to seniors, people with disabilities, and others living with mobility limitations.

We operate in **19 communities** including all of Boulder County, Erie, Estes Park, Brighton and the 1-70 Corridor.

Service is available within communities and between communities. Days and hours of operation vary widely by community.

Trip Cost:

- \$3 one-way within most communities
- \$2 one-way within smaller rural communities
- \$6 one-way between communities

Friends + Family

Occasionally, Via can't provide the service you need. But we're still here to help.

Our Friends and Family Program **reimburses Via riders for the mileage expenses** of family members, friends or neighbors who provide a qualifying trip when Via cannot.

Reimbursement Restrictions:

- \$0.50 per mile
- \$12.50 max per trip
- Max \$100 per month

All requests must be made in advance and you must be a registered rider to qualify for the Friends and Family Program.
