



## Official Notice of the Primary Election Boulder County, Colorado



Election Day – Tuesday, June 26, 2018  
Voting begins June 4, 2018

### PRIMARY ELECTION INFORMATION

Elections in Colorado are conducted by mail ballot with Voter Service and Polling Centers available for those who would like additional assistance or prefer to vote in person. See below for a list of locations and hours/days of operation.

For this Primary Election, ballots will be mailed the week of June 4, 2018.

**Party affiliated electors:** All active, eligible voters who are members of either the Republican or Democratic parties will be mailed their respective party ballot. In Boulder County, no other parties are holding a Primary Election this year. Thus, if a voter is registered with a party other than the Democratic or Republican Party, they will not receive a ballot (deadline to change party registration is May 29, 2018 – visit [www.GoVoteColorado.com](http://www.GoVoteColorado.com) to update registration).

**Unaffiliated voters:** Due to changes in Colorado law, unaffiliated voters may now participate in the 2018 Primary Election. Here are the options:

- 1) **Pre-select a ballot option:** Unaffiliated voters may specify a ballot preference by May 29, 2018. Unaffiliated voters who declare a ballot preference do not formally affiliate themselves with a political party; rather, they simply direct the Clerk and Recorder to include only the preferred ballot in their mail ballot packet. Unaffiliated voters with a ballot preference may also visit a Voter Service and Polling Center and vote either party ballot in-person, so long as they have not already returned their mail ballot. Unaffiliated voters may declare a ballot preference for the 2018 Primary Election at [GoVoteColorado.com](http://GoVoteColorado.com).
- 2) **Receive both ballots:** Unaffiliated voters who do not formally affiliate with a political party or declare a ballot preference by May 29, 2018 will receive a mail ballot packet containing both a Democratic Party and a Republican Party ballot. Unaffiliated voters who receive both party ballots in their mail ballot packet may vote and return only one ballot. If they vote and return both party ballots, neither will count.
- 3) **Affiliation option:** Eligible electors who are not affiliated with a political party may declare an affiliation with a participating political party and vote in the Primary Election. Unaffiliated voters who affiliate with the Democratic Party or Republican Party by May 29, 2018, will receive only that party's ballot in their mail ballot packet. They may also affiliate with one of the participating political parties and vote that party's ballot in-person by visiting a Voter Service and Polling Center.

Ballots must be returned to the Clerk and Recorder no later than 7 p.m. on Primary Election Day (Tuesday, June 26) in order for your votes to be counted. Voters can return their ballot by mail or by dropping it off at any designated ballot drop-off location or Voter Service and Polling Center. Ballots received after 7 p.m. on Election Day will not be counted. Postmarks do not count as a received date.

After returning a ballot, voters can verify that their ballot was received by visiting [www.BoulderCountyVotes.org](http://www.BoulderCountyVotes.org) and checking Ballot Track. Voters may also sign up with Boulder County Votes Ballot Track in order to receive automatic alerts about their mail ballot. Voters can sign up for this free service at any time of year.
