



ADDENDUM #1

The attached addendum supersedes the original Information and Specifications regarding BID #7028-19 where it adds to, deletes from, clarifies or otherwise modifies. All other conditions and any previous addendums shall remain unchanged.

1. Question: Why has the County decided to put this out for bid again and not give Cobitco the opportunity for an extension or renewal as stated on the 2018 contract?

ANSWER: According to the 2018 contract, the County has sole discretion as to whether to extend the term of the contract. In this case, the County wishes to bid to ensure competitive pricing.

2. Question: Why is a supplier/manufacturer now required to provide a payment and performance bond? This is required of a contractor doing in place work for the county and not a supplier/manufacturer.

ANSWER: There will be no Payment or Performance Bond required for this bid; this is an error in the bid document.

3. Question: Material supply contracts typically do not require Payment and Performance Bonds; this has not been included in previous supply bids for Boulder County, is this a new requirement?

ANSWER: There will be no Payment or Performance Bond required for this bid; this is an error in the bid document.

4. Question: This bid requires pricing for material to be delivered to various job locations throughout the county. Can you please provide us with prospective

delivery locations and their estimated quantities so that we can have a basis for our delivery charges?

ANSWER: Deliveries, if required, will be for chip seal projects. The following locations are tentatively scheduled for chip seal in 2019. All locations are within Boulder County. Each location includes the square yards to be treated; we have not yet calculated specific quantities of emulsified asphalt required. It is anticipated that deliveries would be to staging areas near these locations. Not all locations will require deliveries.
