

ADDENDUM #1 Boulder County Resource Conservation Replace MRF Inclined System Feed Chain Conveyor, C-701 RFP # 7052-19

August 21, 2019

The attached addendum supersedes the original Information and Specifications regarding RFP #7052-19 where it adds to, deletes from, clarifies or otherwise modifies. All other conditions and any previous addendums shall remain unchanged.

1. Question: On page 6, it is mentioned: The County will subcontract with an electrician to de-energize and re-energize the conveyor. Can we assume the County is also in charge of the electrical installation (wires or cables connected to motor and other components) if an electrician will be subcontracted? We understand that power will need to be shut off on the conveyor (de-energize and re-energize the conveyor) but cables will also need to be dismantled and reinstalled. Please clarify.

ANSWER: The County will provide wiring to the conveyor motor drop point and connect to energy source. The County will wire the oiler and connect energy source.

2. Question: Please provide the appendix C worksheet mentioned in the RFP.

ANSWER: There is no parts list for the RFP.

3. Question: Will the plant be doing the cleaning of the area we will be working in? If so please specify the cleaning, (deep clean, vacuum, just removal of trash and sweep etc..).

ANSWER: Yes during the project Kick-off meeting we will identify areas that require prep work and the operations team will be responsible for this task.

4. Question: Will the plant be providing a fire watch for the duration of the

work we will be performing?

ANSWER: Yes the operator will arrange for after hour fire watch if the fire suppression system is not operational. During normal operating hours the contractor is responsible for fire watch.

5. Question: Will the plant be providing a laborer?

ANSWER: NO

6. Question: Do we have permission to remove end tail conveyor portion of infeed to the incline conveyor for a more efficient Install?

ANSWER: We do not understand the question. You can remove or reposition conveyor 700 to access 701 if you replace in working condition.
