Beth Haynes Memorial Award

On April 16, 1994, Beth Haynes responded to a domestic violence call shortly before her shift was scheduled to end. She was 26 years old and had been on patrol for about three months. What started as a call for service ended in Beth Haynes being shot and killed by the perpetrator while helping to save the lives of a woman and her children. That same year, the Beth Haynes Memorial Award was established to honor this woman who gave her life so that others could have theirs. It is viewed as one of the most prestigious awards for law enforcement and victim advocates given in Boulder County, voted on and awarded by peers. Each year, the Boulder chapter of Zonta International, which this year celebrates 100 years of empowering women through service and advocacy, generously provides the winner of the Beth Haynes Memorial Award with a scholarship to attend a national conference on domestic violence in order to further the prevention and eradication of violence against women.

As part of the Award, the Boulder County Domestic Violence Task Force also recognizes certain individuals each year with a Special Recognition Award. The Special Recognition Award honors outstanding citizens and advocates in our community who engage in exceptional acts of service for domestic violence victims and survivors.

The 26th Annual Beth Haynes Memorial Awards Ceremony was held on October 17, 2019. The following fourteen nominees were honored at the ceremony, in addition to the winner of the Award and the four winners of the Special Recognition Award. Each one of these nominees and winners has demonstrated excellence not only in their work, but in their ability to recognize the duty we owe to show care and compassion to each other.

The emotional and physical harm that accompanies domestic violence affects more women, children, and men in our community and communities across the country than we will ever know. It is violence perpetrated by a loved one and accompanied by power, control, and manipulation, often in a place that should be the safest for a victim—the home. But while intimate relationships are the stage for domestic violence, the impact of domestic violence reaches far beyond the individuals immediately involved. Recent research shows that in 54% of mass shootings the shooter targeted an intimate partner, and 86% of mass shooting child fatalities are related to domestic or family violence.¹ The Boulder County District Attorney’s Office and its law enforcement and advocacy partners are committed to the fight against domestic violence and the fight for domestic violence victims and the community of Boulder County.


