PLEASE DELETE FEMA ADDENDUM AND SUBSTITUTE THE REVISED FEMA ADDENDUM THAT IS ATTACHED.

1. Question: In regard to payment, will 50% of the entire budget for the 142 acres be held until all projects are done and inspected or does this just apply to each project?

ANSWER: Boulder County will hold 50% of the entire budget until all projects are done and inspected.

2. Question: Are there estimated volumes of wood being removed for each project?

ANSWER: We did not produce inventory data or volume estimates when we performed our individual tree marking and patch cut/aspen regeneration delineations at each project site. In response this question, we have generated a table in the following pages in order to provide rough estimates of volumes of wood to be removed from each site. These rough estimates are based on

inventory data from other sites in the region—not the sites in question. These estimates are not available for all treatment types in all areas. These estimates are for stem wood (to a 4”top); the estimates do not include branches or tops.
