History of post-election audits in CO



- Before 2017, Colorado law required county clerks to conduct random post-election audits after Election Day and before certifying official results
- Starting in 2017, Colorado law required counties to conduct risk-limiting audits (RLAs).
- The Secretary of State (SOS) publishes Election Rules specifying manner in which RLAs must be conducted.
- Colorado was the first state in the nation to conduct and now require a statewide RLA.



What is a Risk-Limiting Audit & why important?



- A type of post-election audit that provides strong statistical evidence that the election outcome is right, and has a high probability of identifying a wrong outcome.
- It is a test that helps ensure the accuracy of election results and provides the public with evidence that election outcomes reflect the votes cast by voters on their ballots.
- RLAs limit the risk that an incorrect election tabulation outcome will escape discovery.
- RLAs are now required after every election. They are conducted in every county.

How the RLA works



To ensure voting system tabulation was accurate, the audit process reviews how a random sample of ballots' votes were captured at the time they were processed by comparing the recorded votes in the Cast Vote Record (the voting system report that lists the individual votes cast for each ballot) to the actual physical paper ballots.

Steps:

- Physically pull the random ballots assigned to us by the SOS
- Enter in the votes from the individual ballots into the RLA software
- The software compares the votes we entered to the votes captures in the Cast Vote Record file we submitted to them
- It notifies us if any discrepancies are found.
- We pass the audit round if no discrepancies are found.
- If a discrepancy is found we address it in coordination with the SOS
- There can be additional rounds of audits, even if Boulder County finds no discrepancies.



RLA Preparation



Boulder

- Ballots have no unique identifying numbers on them when printed.
- During the scanning process, a unique identifying number is imprinted on each ballot.
- This unique number is captured in the Cast Vote Record along with the individual votes from that ballot.
- The Cast Vote Record file is securely submitted to the Secretary of State's office on the 9th day following the election (after military/overseas mail deadline / deadline for cured ballots)

Secretary of State

- Maintains the open-source RLA software used by counties to conduct the risk limiting audit.
- The SOS establishes the random seed (public meeting, involves dice rolling)
 with the audit software. The random seed then determines and assigns
 individual unique ballots to each county to pull.



Audit Board Duties



Perform Audit Duties as outlined in: C.R.S. 1-7-515 and Election Rule 25, which include:

- Observe the location and retrieval of ballots by county staff from the appropriate storage container.
- Must verify that the seals on the appropriate storage containers are those recorded on the applicable chain-of-custody logs.
- ✓ Interpret voter markings on ballots selected for audit in accordance with the SOS Voter Intent Guide.
- ✓ Sign and date a report of the results of the RLA.
- ✓ Canvass Board Observe the audit.



Process Overview



- Ten Audit Board Teams (bi-partisan, RLA application operator)
- Approximately 5 ballots per team
- May include withdrawn candidates
- Voter Intent Guide (as needed)
- Duplication information (as applicable)
- Tips accuracy, verify information, noise, observers/watchers

Colorado Revised Statutes - Title 1

- 1-10-101.5. Duties of the canvass board
 - (a) Reconcile the ballots cast in an election to confirm that the number of ballots counted in that election does not exceed the number of ballots cast in that election;
- Note, this is at the county level not the precinct level
- Refer to Appendix 1



Colorado Revised Statutes - Title 1

- 1-10-101.5. Duties of the canvass board
 - (b) Reconcile the ballots cast in each **precinct** in the county to confirm that the number of ballots cast does not exceed the number of registered electors in the precinct;
- Refer to Appendix 1




Colorado Revised Statutes - Title 1

- 1-10-101.5. Duties of the canvass board
 - (c) Certify the abstract of votes cast in any election and transmit the certification to the secretary of state. A majority of canvass board members' signatures shall be sufficient to certify the abstract of votes cast in any election. When unable to certify the abstract of votes by the majority of the board for any reason, the canvass board shall transmit the noncertified abstract of votes to the secretary of state along with a written report detailing the reason for non-certification.

Track Active Voters to Envelopes/Ballots Cast

- Checked daily throughout the election process
- Differences researched and documented
 - ✓ Impacted by voter moves
 - 1. Within Boulder County
 - 2. Moved out of Boulder County
 - 3. Moved in to Boulder County
 - ✓ Impacted by voter status changes
 - ✓ Election Statute [8 CCR 1505-1], Rule 7.2.4(a)(2)(b) states that "the county must count the first ballot returned by the elector in accordance with section 1-7.5-107(6), C.R.S.".



Within County Moves

- Voter A moved to precinct 901 from precinct 875
 - Returned their originally issued envelope for precinct 875
 - Active Voter is located within precinct 901
 - Vote Credit is assigned to the voter (wherever they are currently registered)
 - SCORE Vote Credit is assigned to precinct 901
 - Impacts statute 1-10-101.5(b) Ballots Cast Registered Electors
 - Has a negative impact to precinct 901
 - Has a positive impact to precinct 875



Out Of County Moves


- Voter B moved to Boulder County precinct 107 from Arapahoe County
 - ✓ Returned their Arapahoe County envelope/ballot
 - ✓ Active Voter is located within Boulder County precinct 107
 - No Vote Credit is assigned from Boulder County
 - Boulder County envelope/ballot is voided
 - ✓ Impacts statute 1-10-101.5(b) Ballots Cast Registered Electors
 - Has a negative impact to precinct 107
- Voter C moved to Larimer County from Boulder County Precinct 833
 - ✓ Returned their Boulder County envelope
 - ✓ They are no longer an Active Voter in precinct 833
 - ✓ However, they returned their ballot, so we assign vote credit to 833.
 - ✓ Impacts statute 1-10-101.5(b) Ballots Cast Registered Electors
 - Has a positive impact to precinct 833



Voter Registration Status Changes

- Voter D received and returned their envelope/ballot for precinct 999
- Then...Voter D had a voter registration status change
 - ✓ Incomplete (address doesn't exist, etc.)
 - Cancelled (felony conviction, death, or out of state move)
 - ✓ Inactive (undeliverable ballot, etc.)
- There is no longer an Active Voter in precinct 999 to associate to the Active ballot cast
- Vote Credit is assigned to 999
 - May or may not be a Reject situation
- Impacts statute 1-10-101.5(b) Ballots Cast Registered Electors
 - ✓ Has a positive impact to precinct 999





Ballots Counted (Appendix 1)



Reconcile Ballots Counted to Vote Credit

- Differences researched and documented (identify scenario if possible and when they affect the overall numbers)
 - ✓ Impacted by voter moves
 - Within Boulder County
 - Moved out of Boulder County
- Other situations that procedurally won't be adjusted, and will create differences
 - ✓ Voters within a household swap envelopes (spouses, roommates, households, etc.)
 - Replacement envelopes
 - This would be a case where a voter moves to a different precinct but receives their original ballot, they request a replacement ballot for their new precinct. They then accidentally swap the ballot and envelope creating vote credit that goes with the envelope and a ballot counted in a different precinct



Reconcile Ballots Counted to Vote Credit

- Explanation of Differences (Net 4 at County Level)
- In compliance with the COVID-19 Disaster Declaration set forth in Colorado Executive Order D 2020 003 by Governor Polis, the Boulder County Public Health Disaster Declaration and Executive Order D 2020 005, the Elections Office closed to the public on March 16 and staff transitioned to working from home. As a result, full access to the necessary documents, equipment and resources to thoroughly investigate all differences was not possible.





Reconciliation Report

March 3, 2020

OVERVIEW

The purpose of the canvass is to account for every ballot cast and ensure that every valid vote cast is included in the election totals. This involves accounting for every mail ballot, in-person ballot, provisional ballot, challenged ballot, and military and overseas ballot (UOCAVA).

Colorado Revised Statutes, Title 1, 1-10-101.5 Duties of the canvass board:

- 1) The canvass board shall:
 - (a) Reconcile the ballots cast in an election to confirm that the number of ballots counted in that election does not exceed the number of ballots cast in that election;
 - (b) Reconcile the ballots cast in each precinct in the county to confirm that the number of ballots cast does not exceed the number of registered electors in the precinct; and
 - (c) Certify the abstract of votes cast in any election and transmit the certification to the secretary of state. A majority of canvass board members' signatures shall be sufficient to certify the abstract of votes cast in any election. When unable to certify the abstract of votes by the majority of the board for any reason, the canvass board shall transmit the noncertified abstract of votes to the secretary of state along with a written report detailing the reason for noncertification.

The Canvass Board's duties regarding reconciliation are included in Election Rule 10.3.2(a):

- (a) Conduct the canvass in accordance with section 1-10-101.5, C.R.S, including:
 - (d) Account and balance the election and certify the official abstract of votes;
 - (e) Reconcile the number of ballots counted to the number of ballots cast; and
 - (f) Reconcile the number of ballots cast to the number of voters who voted by reviewing the reconciled detailed ballot logs and Statement of Ballots.

To reconcile the election, we track voted ballots as they pass through the election process. This report will present summary data as required by Election Rule 10.5.1 regarding the overall election, a detailed accounting of ballots on a precinct-by-precinct basis, and references the reports that contain the information and evidence to allow the Canvass Board to fulfill its statutory duty. The reconciliation process focuses on the reception of ballots through the assignment of voter credit.

BALLOTS RECEIVED (ACCEPTED OR REJECTED)

Mail ballots are received in several ways:

- Post Office
- Secure 24-hour ballot drop boxes
- Drop-off ballot boxes located at Voter Service and Polling Centers, and
- Drive-by drop-off locations

The mail ballots are signature verified by election judges, accepted or rejected, and recorded accordingly in SCORE. Voted paper ballots from Voter Service and Polling Center (VSPC) locations arrive in separate ballot boxes from the mail-in ballots. Because vote credit was already recorded in SCORE and their ID was verified at the VSPC locations, these ballots go directly to scanning, adjudication, and tallying after being batched. Figure 1 illustrates the process by which mail ballots are received, prepared, scanned and tallied and recorded in the CVR (Cast Vote Record).



Determining whether a ballot is accepted or rejected is based on several factors. For example, it may be rejected because the signature on the ballot envelope does not match the voter registration record, the envelope may be missing a signature, or the returned ballot envelope may be missing a required ID.

Letters are sent to these voters allowing them to "cure" their ballot envelope by returning a signed affidavit with a copy of their ID (due by the 8th day after the election). Only the ballots associated with accepted envelopes proceed through the process to scanning, adjudication, and tallying; there were 2,464 rejected ballots and the breakdown of these numbers are summarized in Figure 6 (data from SCORE BP-012B - Mail Ballot Reconciliation Report).

Appendix 1 provides a precinct-by-precinct accounting of eligible voters, ballots received, and ballots counted. To fulfill the statutory requirement of Election Statute [8 CCR 1505-1], and Rule 10.3.2(a), Appendix 1 includes four sections:

- 1. Eligible Voters
- 2. SCORE Voter Credit and Ballots Cast
- 3. Dominion Ballots
- 4. Reconciliation

The Eligible Voters section includes both active and inactive voters, providing the total number of registered electors. On the received side (SCORE Voter Credit and Ballots Cast), is the number of ballots accepted in SCORE for: (1) Mail-In, (2) In-Person voters and (3) number of rejected ballots; the sum of these three categories provides the number of ballots cast. On the counted side (Dominion Ballots), is a column that accounts for the number of ballots counted by the

tabulation system (Dominion). The Reconciliation section provides the information to fulfill the statutory requirements and assist with the duties of the canvass board. Based on these numbers, we can confirm that the number of ballots counted (136,425) does not exceed the number of ballots cast (138,898). A summary table illustrating Ballots Cast and Ballots Counted is provided in Figure 13 below. We can also confirm that the number of ballots cast in each precinct in the county does not exceed the number of registered electors in that precinct. In addition, we have reconciled the number of ballots counted to the number of voters that received vote credit. At the county level, we have a difference of -4 between ballots counted and vote credit; we have 4 more vote credit then ballots counted. In compliance with the COVID-19 Disaster Declaration set forth in Colorado Executive Order D 2020 003 by Governor Polis, the Boulder County Public Health Disaster Declaration and Executive Order D 2020 005, the Elections Office closed to the public on March 16 and staff transitioned to working from home. As a result, full access to the necessary documents, equipment and resources to thoroughly investigate all differences was not possible.

As outlined in Rule 10.5.1, the designated election official must provide the following information to the canvass board:

- (a) The name of each candidate, office, and votes received; (Summary of Votes attachment)
- (b) The number or letter of each ballot issue or question and votes received; (Summary of Votes attachment)
- (c) The total number of ballots cast; (Appendix 1)

The Active Voters number above includes 581 confidential voters. Confidential voters will not be identified in any publicly available reports. Of the 6,524 In-Person voters reported above, 370 of them voted on an electronic Ballot Marking Device (ICX).

Ballots Cast includes ballots that are ultimately not counted for various reasons. Voters have until 11:59 p.m. on the 8th day following Election Day to rectify these issues. However, not every voter does so in this timeframe. If they do not, their cast ballot is not counted.

EXECUTIVE ORDER

Directing State Parties and Secretary of State to Amend Rules Regarding In-Person Gatherings to allow the 2020 Primary Election to Proceed without Interruption, in light of the Disaster Declaration set forth in Executive Order D 2020 003

In light of the earlier declaration of a State disaster emergency in Executive Order D 2020 003 due to the presence of COVID-19 in the State of Colorado, and pursuant to the authority vested in the Governor of the State of Colorado and, in particular, pursuant to Article IV, Section 2 of the Colorado Constitution and the relevant portions of the Colorado Disaster Emergency Act, C.R.S. § 24-33.5-701, et seq. (Act), I, Jared Polis, Governor of the State of Colorado, hereby issue this Executive Order suspending certain laws governing the conduct of the 2020 primary election.

I. Background and Purpose

On March 5, 2020, the Colorado Department of Public Health and Environment's (CDPHE) public health laboratory confirmed the first presumptive positive COVID-19 test result from Colorado. Since then, CDPHE confirmed more than one hundred sixty (160) additional presumptive positive cases and concluded that Colorado is experiencing community spread of the disease. I declared a disaster emergency on March 11, 2020 and issued Executive Order D 2020 003.

COVID-19 is a highly contagious viral disease that has spread throughout many of our State's communities. Public health officials concluded that disease control measures aimed at specific individuals or groups are no longer sufficient to contain the further spread of the virus. Since COVID-19 was first detected in Colorado, numerous school districts have closed, institutions of higher learning have shifted to virtual instruction, and local governments across the State have prohibited large social gatherings. Per my instruction, CDPHE and the Colorado Department of Human Services issued emergency rules limiting visits to facilities that serve older Coloradans.

The circumstances surrounding COVID-19 change quickly and our response must include planning for the future to protect public health and safety while we carry out essential State business. The State's political parties will be conducting district, county, and State assemblies and conventions pursuant to law in the coming months. To ensure that these functions proceed without interruption and consistently with any emergency rules, guidelines, or orders in place pursuant to Executive Order D 2020 003, the General Assembly passed House Bill 20-1359 (HB20-1359) to allow Colorado's major political parties to amend certain rules and procedures governing the conduct of their assemblies and conventions and the resulting

designations of party candidates to the primary election ballot. I signed HB20-1359 into law simultaneously with this Executive Order.

By this Executive Order, I incorporate, by reference, the measures taken by the General Assembly in HB20-1359 and further direct the major political parties to make any amendments necessary to their bylaws to comply with any emergency order issued pursuant to Executive Order D 2020 003 or any relevant subsequent executive order. I also direct the Secretary of State to set deadlines consistent with any amended party rules and bylaws and take appropriate actions to allow the primary election scheduled for June 30, 2020 to proceed without interruption. We will continue to monitor the course of the COVID-19 outbreak in the State and may amend this Executive Order accordingly.

II. Directives

- A. I hereby incorporate, by reference, the measures taken by the General Assembly in HB20-1359 and direct the Secretary of State to set deadlines by which the State parties must file a certified copy of any amended rules and bylaws.
- B. I hereby direct that the major parties make any changes necessary to their rules to comply with restrictions that may arise due to the disaster emergency declared in Executive Order D 2020 003, including but not limited to, changes to proxy or quorum requirements, and that any such changes to party rules can be done outside the existing political party rules process.
- C. I hereby suspend all requirements for public meetings or in-person transactions under Title I of Colorado Revised Statutes and 8 Colorado Code of Regulations 1505-1 and 1505-3 and direct the Secretary of State to promulgate and issue emergency rules that allow all eligible voters to participate in the June 30, 2020 election in a manner that complies with any emergency order issued under Executive Order D 2020 003 or any related subsequent order or any guidance issued by CDPHE. I further direct the Secretary of State to work with appropriate personnel at CDPHE as these rules are developed.
- D. I hereby suspend any notarization or handwritten signature requirements in any rules, regulations, or forms regarding the certification or acceptance of nomination, selection, or appointment pursuant to C.R.S. §§ 1-4-601, 12-203, 12-206 and direct the Secretary of State to promulgate and issue emergency rules that allow for the use of electronic means regarding the certification or acceptance of nomination, selection, or appointment under C.R.S. §§ 1-4-601, 12-203, 12-206.
- E. Nothing in this Executive Order waives the requirement set forth in C.R.S. § 1-5-203(1)(a) requiring that any names be submitted to the Secretary of State not later than sixty (60) days prior to an election.

This Executive Order shall expire thirty (30) days from March 16, 2020, unless extended further by Executive Order.
