The attached addendum supersedes the original Information and Specifications regarding SOQ # 7122-20 where it adds to, deletes from, clarifies or otherwise modifies. All other conditions and any previous addendums shall remain unchanged.

Please note: Due to COVID-19, BIDS will only be accepted electronically by emailing purchasing@bouldercounty.org.

1. Question: Will Boulder County accept SOQs that provide some but not all services listed in the cost table?

ANSWER: Yes. Preference will be given to those that are able to perform most of the services. As stated in the "Submittal Section" of the SOQ, "We are requesting proposals from individual contractors and not teams." However, if contractors can show efficiency and minimal to no extra mobilization costs due to teams, this may be considered.

2. Question: Does Section 107.24 exclude the use of gasoline powered vehicles and trucks?

ANSWER: As further detailed in the specification please note, “(d)Definition. Vehicle, for the purposes of this specification, is defined as any diesel-powered company owned car or truck. It does not apply to personal vehicles.”

In addition, this specification speaks to when diesel powered equipment or vehicles is used and doesn’t apply, nor exclude, use of gasoline powered vehicles.

3. Question: Does Boulder County have required insurance liability limits? If so, what are the required liability limits?

ANSWER: Typical Insurance Limits are given in the “SAMPLE CONTINUING SERVICES CONTRACT” under Item 42 Insurance Requirements.

4. Question: Please confirm if resumes are included in the 20-page limit.

ANSWER: Yes, resumes are part of the 20-page limit.

5. Question: Can resumes be included in an appendix with bios in the SOQ?

ANSWER: No and appendices are not allowed.
