

Official Notice of the Primary Election Boulder County, Colorado



Election Day – Tuesday, June 30, 2020 Ballots mailed beginning June 8, 2020 **PRIMARY ELECTION INFORMATION**

Elections in Colorado are conducted by mail ballot with Voter Service and Polling Centers (VSPCs) available for those who would like additional assistance or prefer to vote in-person. See below for a list of locations and hours/days of operation.

For this Primary Election, ballots will be mailed beginning the week of June 8, 2020. You must be registered as a Democrat, Republican, Libertarian, or Unaffiliated voter to participate.

Party affiliated voters: All active, eligible voters who are members of the Democratic, Republican, or Libertarian parties will be mailed their respective party's ballot. In Boulder County, no other parties are holding a primary election. The **deadline to change or withdraw party affiliation is Monday, June 1, 2020** – visit www.GoVoteColorado.gov to update your registration.

Unaffiliated voters: By law, if no ballot preference is specified by June 1 (optional only; updates to voter ballot preference can be made at www.GoVoteColorado.gov), all active, eligible unaffiliated voters will be mailed a packet containing both a Democratic and Republican Party ballot. **Unaffiliated voters may only vote and return only one ballot** (if both ballots are voted and returned, neither ballot will be counted). To receive a Libertarian ballot, unaffiliated voters must either preselect the Libertarian ballot by June 1 or contact our office after June 1 for voting options.

Voters have three options for returning their ballot: mail, 24-hour drop box, or VSPC location. Ballots must be returned by 7 p.m. on Election Day (Tuesday, June 30). Ballots received after 7 p.m. on Election Day will not be counted. Postmarks do not count as a received date. If mailing your ballot, it is recommended to mail it no later than Monday June 22, 2020.

Voters can sign-up to receive text, email, or voice messages when their ballot is printed, mailed, and received by Boulder County Elections by enrolling in Ballot Track on our website: <u>www.BoulderCountyVotes.org</u>. This is a free service.

There is no voter registration deadline (see above for party affiliation deadline). You can register and vote up to and including Election Day, however, given the urgent public health crisis with COVID-19, the Boulder County Elections Division is urging residents to register now and not wait so you can receive your mail ballot and avoid the need for an inperson visit.

If you make a mistake, damage or lose your ballot, you may request a replacement ballot by emailing Vote@BoulderCountyVotes.org, calling 303-413-7740, or by visiting a Voter Service and Polling Center.



Voter Service and Polling Centers – See below for schedule of openings and days/hours available. Services include:

- Drop off your ballot
- Register to vote or update your registration information
- Cast a ballot in person
- Vote using equipment and facilities for persons with disabilities
- Request a replacement ballot

Note: Due to COVID-19, voters and elections judges alike will be following Boulder County Public Health protocols, which include wearing face-coverings and maintaining 6-foot physical distancing between individuals.
