- PI The individual is licensed to install pumping equipment in water wells. The license may be limited to installation of pumping equipemtn based on the horsepower of the pump. If the license is not limited, the individual may install all types of pumping equipment.

- B The individual is licensed to construct wells and install pumping equipment in wells.

- SP The individual holds a special license to perform specifcic limited work on water wells as specified in the limitations section on the license.

- SPCO The individual hold a special license limited to specific type(s) of water well construction, for example construction of a well using a backhoe.
