

ADDENDUM #1 Public Works – Resource Conservation Division Hazardous Waste Services RFP # 7240-21

June 18, 2021

1. Question: Please provide the most current pricing (that includes pricing escalators) from the last successful winning bidder and the name of the bidder?

ANSWER: The records responsive to your request are available on the Boulder County Open Records Center under the <u>Public Records Archive</u>. Please visit the Public Records Archive to search for the records using key terms or the Request number P001641.

Please note that in response to request P001641, Boulder County determined that a portion of the records requested are exempt and/or have been redacted

for the following reasons:

2. Question: Please provide the awarded 2016 pricing from the winning bidder?

ANSWER: Please see the answer to question 1.

3. Question: How many years has the Incumbent Contractor held this contract?

ANSWER: Five years (2016-2021)

4. Question: Can the County provide a copy of all waste profiles?

ANSWER: We cannot provide this information at this time.

5. Question: Please provide annual waste stream volumes for each waste stream?

ANSWER: Please see Appendix A that was provided in the bid documents.

6. Question: Please provide copies from the last two year for hazardous and nonhazardous waste manifests?

ANSWER: We cannot provide this information at this time.

7. Question: What is the budget for the term of the new contract?

ANSWER: The budget will be determined once we award our contract.

8. Question: Does the County have approved recycler and TSDF list they prefer to stay with?

ANSWER: The County does not have a preference on recycler of TSDF. We would only use sites that are permitted by CDPHE.

9. Question: Is the County open to any/all fully permitted/licenses TSDFs that the State of Colorado approves?

ANSWER: Yes

10. Question: Is the County open to adding a Subtitle C Hazardous Waste permitted TSDF that could bring cost-savings? If so, what would the turnaround time be (to add a TSDF)?

ANSWER: Boulder County is not interested in adding a TSDF site to county property. The permitting process with CDPHE is very lengthy and could take years to complete.

11. Question: Will the County be open to negotiation on any waste streams not currently in pricing?

ANSWER: Yes

12. Question: Is there a different pricing structure for the VSQG pricing?

ANSWER: Boulder County hopes the pricing for HHW and VSQG will be the same for each waste stream if the vendor agrees.

13. Question: What is the contract term for this opportunity? How long do unit rates need to be firm?

ANSWER: The contract is for one year with the opportunity for four additional one-year terms.

14. Question: How often does County require removal services from permanent site?

ANSWER: We typically ship every four to twelve weeks depending on usage at the facility. Oil-based paint may be picked up more frequently at every two to four weeks.

15. Question: How many containers are normally shipped per pickup? Are there any specific requirements for the transportation vehicle? (size limitations, liftgate, etc)

ANSWER: We shipped 101 containers on 44 pallets on our last waste shipment. The site can accommodate a 53" semi and we can use the Boulder County forklift to load the truck. There are no vehicle restrictions for this site.

16. Question: How is the pricing going to be evaluated to determine low bidder? (will volumes in A1 be used to extend vendor rates?)

ANSWER: Pricing will be evaluated by the total cost of expenses for one year.

17. Question: The bid indicates that the oil & antifreeze are collected by a separate vendor; are these categories part of Pricing evaluation?

ANSWER: We would NOT include these waste streams in the price evaluation and encourage bidders to provide pricing for events.

18. Question: The same question applies to these streams as well: Lead acid batteries, Light tubes, and batteries. All of these items are on price sheet however serviced by other vendors; are these part of evaluation?

ANSWER: If the vendors can offer competitive pricing for these waste streams, Boulder County may consider shipping these waste streams with the vendor. In the past, we've been able to find more competitive pricing and haven't shipped these specific waste streams with the hazardous waste vendor. We would NOT include these waste streams in the price evaluation and encourage bidders to provide pricing for events.

19. Question: Scope indicates that Latex paints are shipped through Paint-Care approved vendors. Does this mean that the State PaintCare Program is paying for this item? Do we need to price this on the bid sheet?

ANSWER: Yes, PaintCare will be paying for the latex paint disposal. No, you do not need to price this item on the bid sheet. Please ensure that you will work with PaintCare to dispose of latex and oil-based paints.

20. Question: Is the County sending Oil based paints through Paintcare contract also? Does this line item need to be priced since this should be no cost to the County?

ANSWER: Yes, PaintCare will be paying for the oil-based paint disposal. No, you do not need to price this item on the bid sheet. Please ensure that you will work with PaintCare to dispose of latex and oil-based paints.

21. Question: Can we have a tour of permanent site?

ANSWER: Yes, Boulder County will host an optional tour for potential bidders on Friday, June 25, 2021 at 11 a.m. Please notify the Hazardous Materials Program Manager at <u>sfuller@bouldercounty.org</u> by 4:30 p.m. on June 24, 2021 if you are interested in attending. Masks are required.

22. Question: Does the County have preferred container size per each waste category that you prefer to use? Ex. 55 drums for pour-off items.

ANSWER: Most waste streams will be shipped in 55-gallon drums. If more cost-effective, we will use cubic yard boxes from certain waste streams like aerosols, paint related materials, and solid toxic/poisons. At events and for VSQG we may ship smaller containers so we like to have pricing for all options available.

23. Question: Is the oil tested prior to being added to storage tank for PCBs?

ANSWER: No, we use a combustible gas detector to check for combustible gases and halogenated solvents.

24. Question: What type of antifreeze is collected in bulk (ethylene glycol / polypropylene OR are the mixed)

ANSWER: We receive a mixture of ethylene and polypropylene glycol.
