 - c. Any changes we are proposing to use are due to DRCOG by April 25
 - Last cycle we weighted reviewers responses, to account for varying levels of "harshness" among the scorers. (1 staff from each agency scores all applications, except their own agencies)
 - e. DRCOG staff will score up to 15 BoCo subregional applications if we would like them to
 - f. Potential modifications to Regional TIP application:
 - i. Increased emphasis on safety/VZ, GHG emissions/ air quality, and multimodal options, especially for vulnerable populations
