EMULSIFIED ASPHALT PRODUCTS

Cationic Rapid Setting Emulsified Asphalt, Polymer Modified (CRS-2R)

CRS-2P shall be an emulsified blend of asphalt, <u>SBR polymer</u> dispersion, water, and emulsifiers. The emulsified blend shall contain a minimum of three (3.0) percent styrene butadiene rubber (SBR) by weight of asphalt cement. The emulsion shall be smooth and <u>homogeneous throughout</u>, and suitable for pumping and application through a distributor truck. The <u>emulsified asphalt</u> shall conform to the following requirements:
