

ADDENDUM #1 Public Works - Building Services SE County Hub Flooring Finishes BID # 7356-22

The attached addendum supersedes the original Information and Specifications regarding BID # 7356-22 where it adds to, deletes from, clarifies or otherwise modifies. All other conditions and any previous addendums shall remain unchanged.

1. Question: I noticed that that the workout and cardio room are spec'd for ecore. Regupol America is a main sports flooring provider along with Tarkett Sports and Robbins. The Aktiv Thunder Gray would be the sub for the ecore monster charcoal and Tarkett's Classic Oak or Golden Oak would be the sub for the ecore forest rx toasted oak. Are you open to substitutions on this project?

ANSWER: Substitutions are allowable as long as they are closely match specifications for performance, warranty, and color. The proposed Golden Oak and Classic Oak from Tarkett are both much too yellow; we prefer a color more like the specified flooring. Also note we would like to change the Monster Product in the workout room to one of the following products: <u>ECOfit | EcoSurfaces</u> 8.2 mm thick – roll <u>ECOfit Plus | EcoSurfaces</u> 15.2 mm thick – roll or interlocking tile option Closely matched substitutions are still allowable, however.
