NOTE WORTHY UPDATES FOR AUGUST 2022

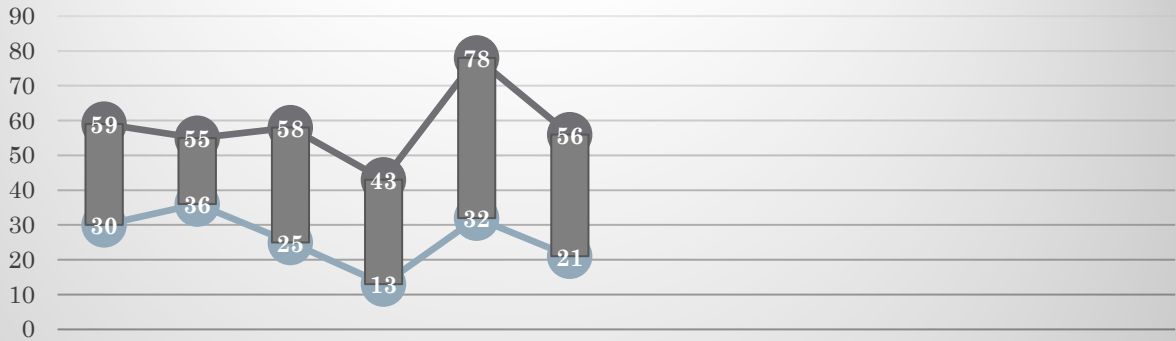
- Boulder County Outreach Collaborative is working to create a “real-time” shared calendar with the aim to connect individuals encountered during outreach and engagement activities to other services providers also the field.
- Directors of partners and homeless providers continue to work collaboratively to identify funding opportunities to ensure duplication of services do not occur throughout Boulder County.

OVERVIEW OF DATA IN BRIEFING

- Overall, the number of Coordinated Entry screenings were higher, annually, compared to same timeframe as last year.
 - City of Boulder was up 12% annually but decreased 12% during the month of June
 - City of Longmont was up 16% annually but decreased 19% during the month of June
- Diversion exits were down by 45% compared to this time last year.
- 127 individuals have exited homelessness between January 1, 2022 through June 30, 2022 (an overall decrease of 2% compared to the same timeframe as last year).
 - Increase of 3% in City of Boulder
 - City of Longmont is exiting the same number of individuals compared to this time last year
 - Decrease of 19% exited from HMIS data system

Coordinated Entry Screenings FY 2022



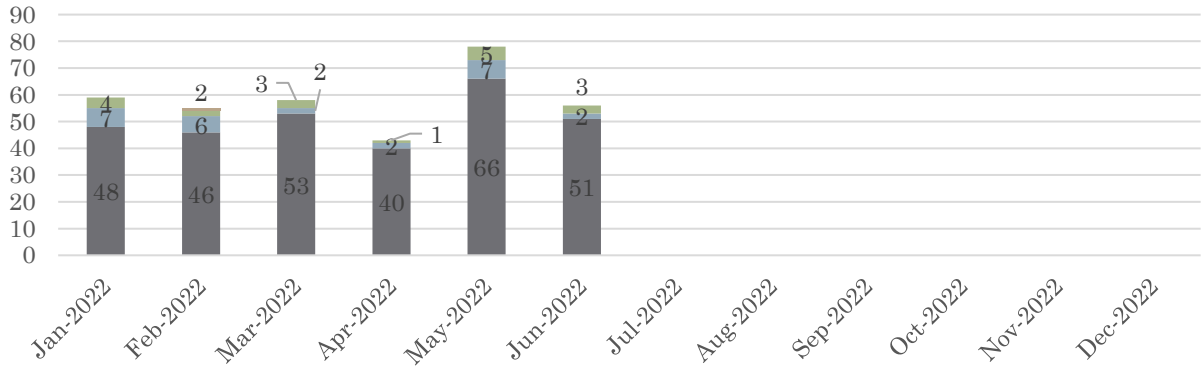

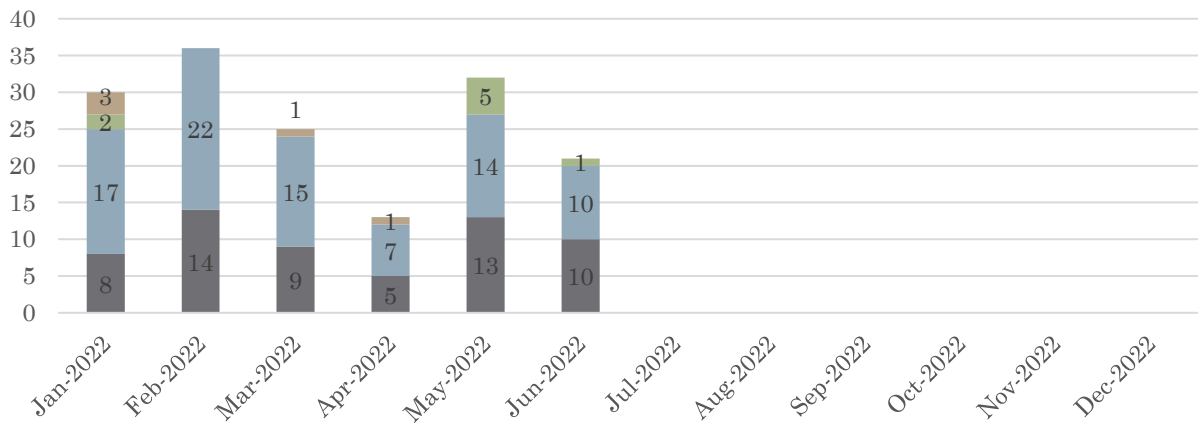

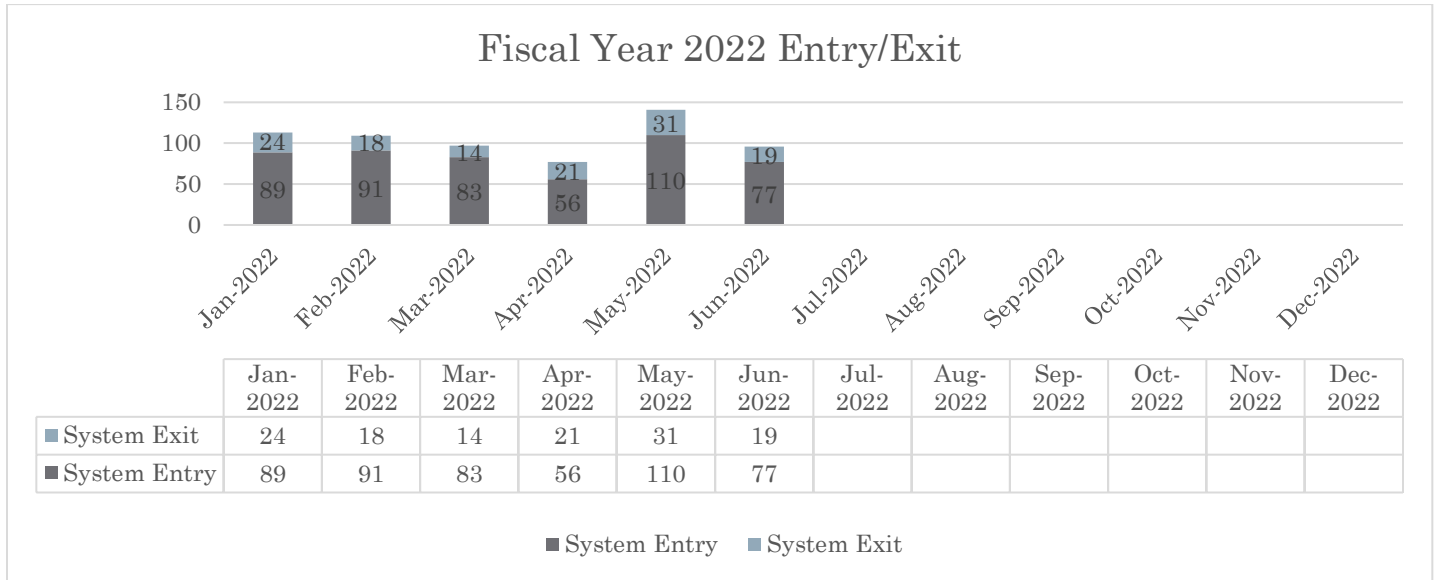

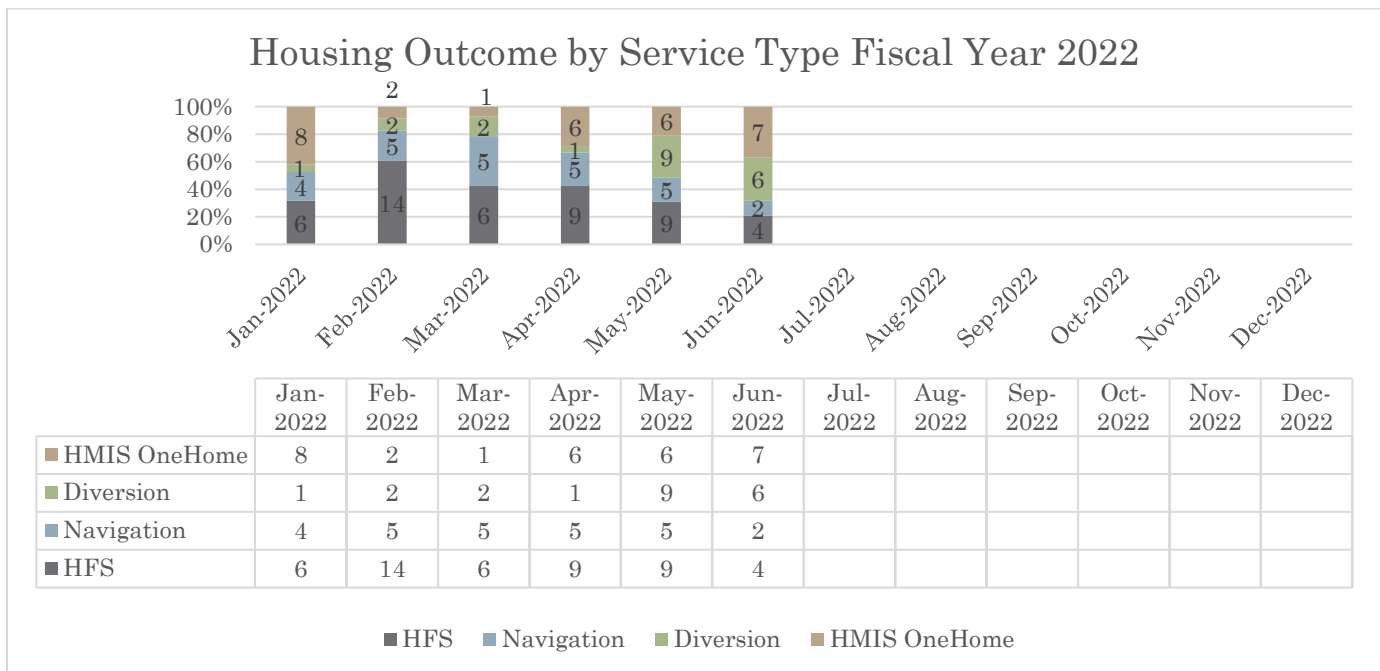

SYSTEM ENTRY/EXIT AUGUST 2022

Since January 2022, 25% (127) exited homelessness into a stable housing situation.



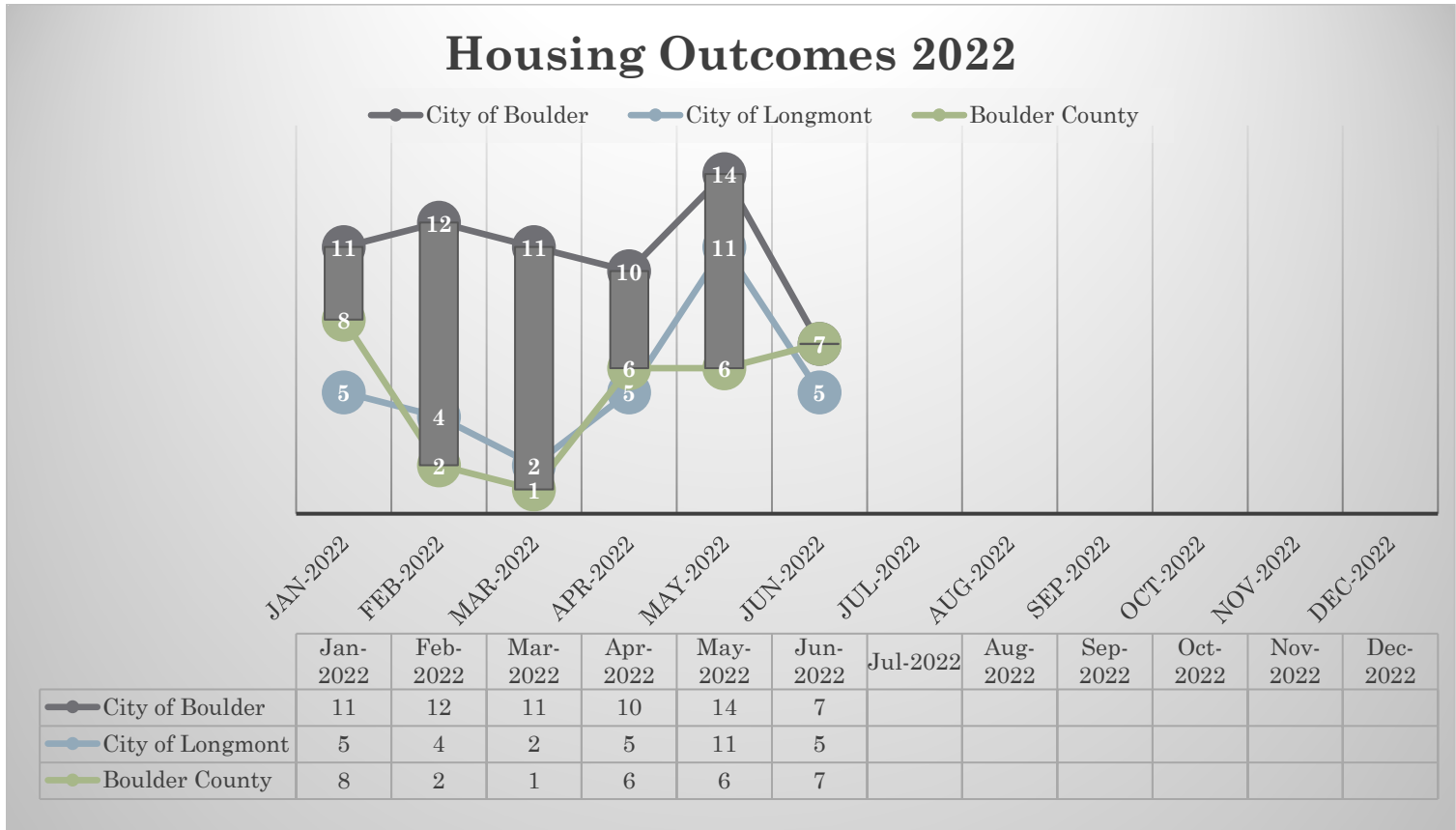
SYSTEM EXIT PROGRAM TYPE¹

HOUSING OUTCOMES FISCAL YEAR BY COORDINATED ENTRY INITIATED SITE 2022

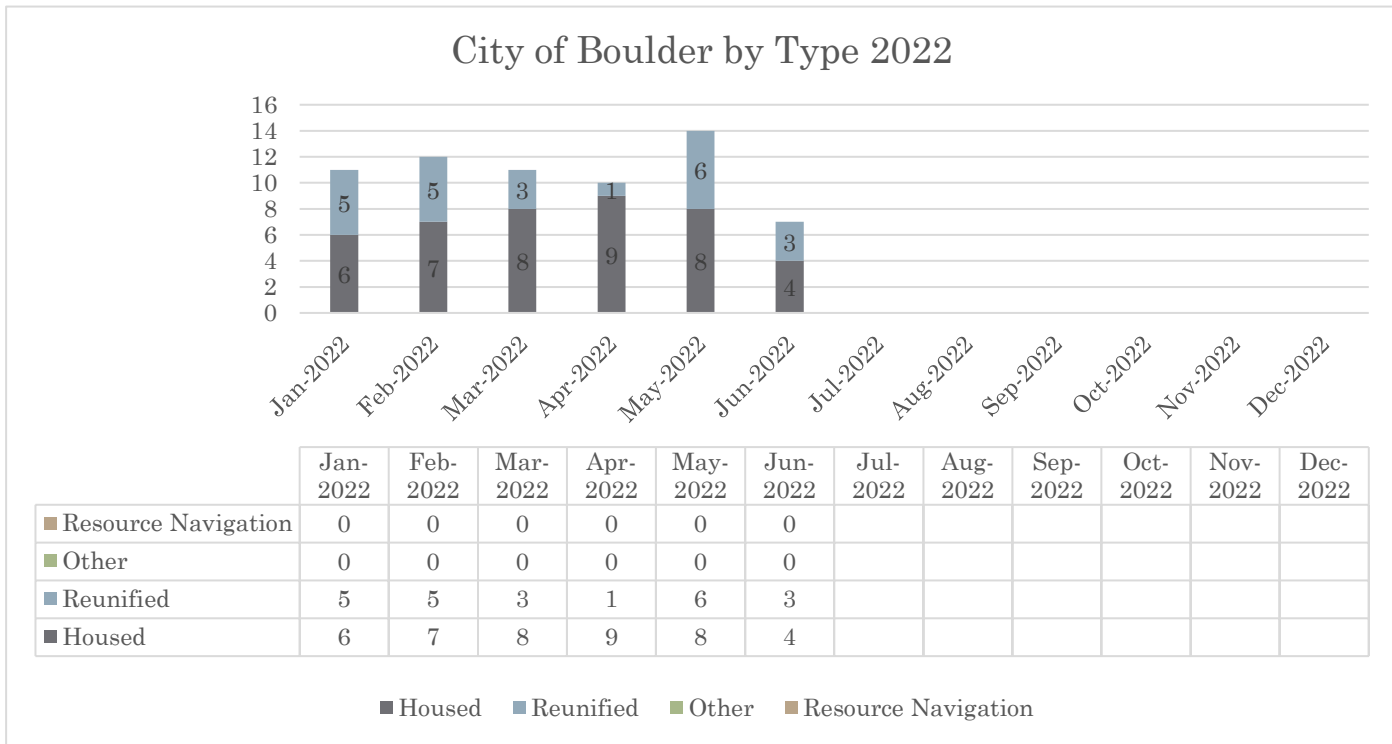
As reflected, a total of 127 individuals experiencing homelessness exited homelessness since January 2022 with 65 (51%) from the City of Boulder, 32 (25%) from the City of Longmont and 30 (24%) Boulder County².

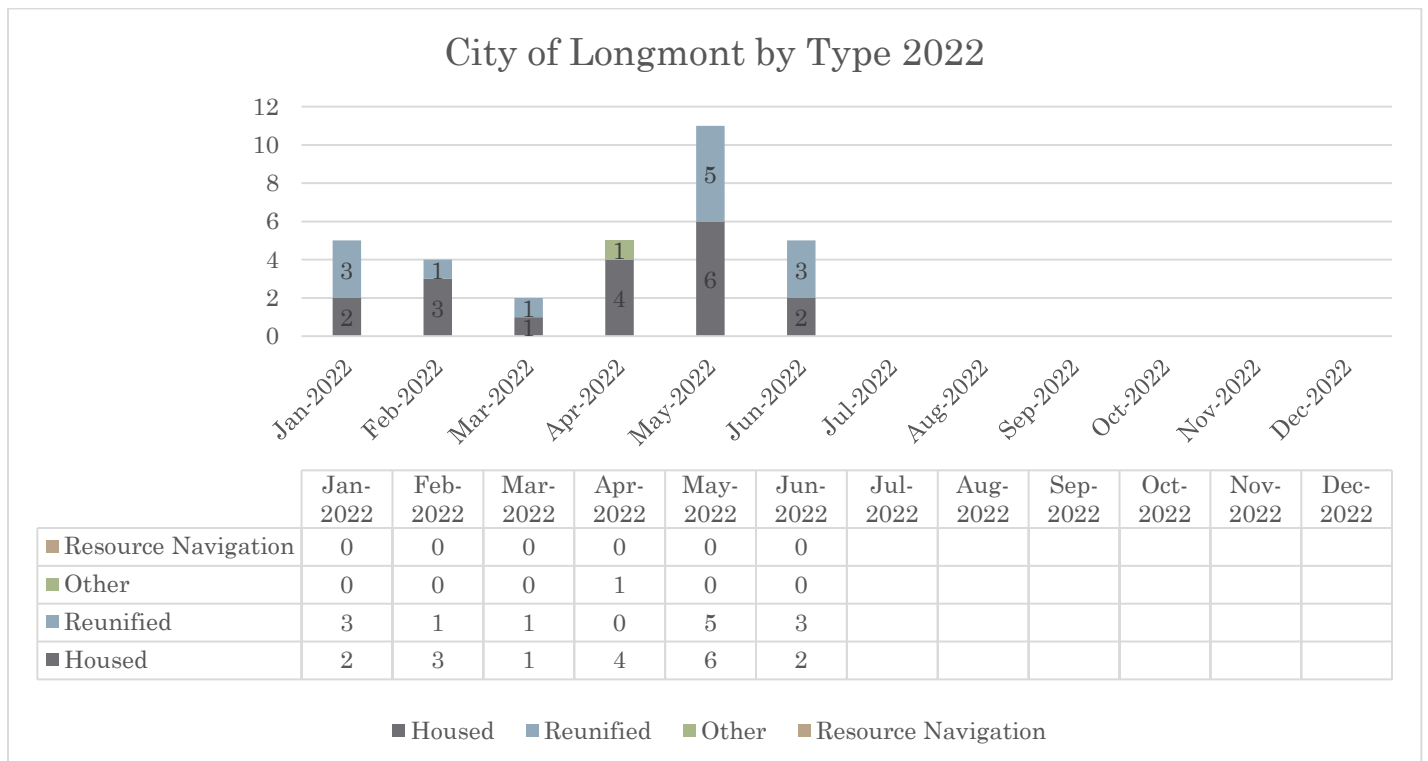
HOUSING OUTCOME BY EXIT TYPE CITY OF BOULDER 2022

Since January 2022, in the City of Boulder, a total 65 individuals have exited homelessness with 38 (65%) individuals exited to housing and 23 (35%) through Reunification.



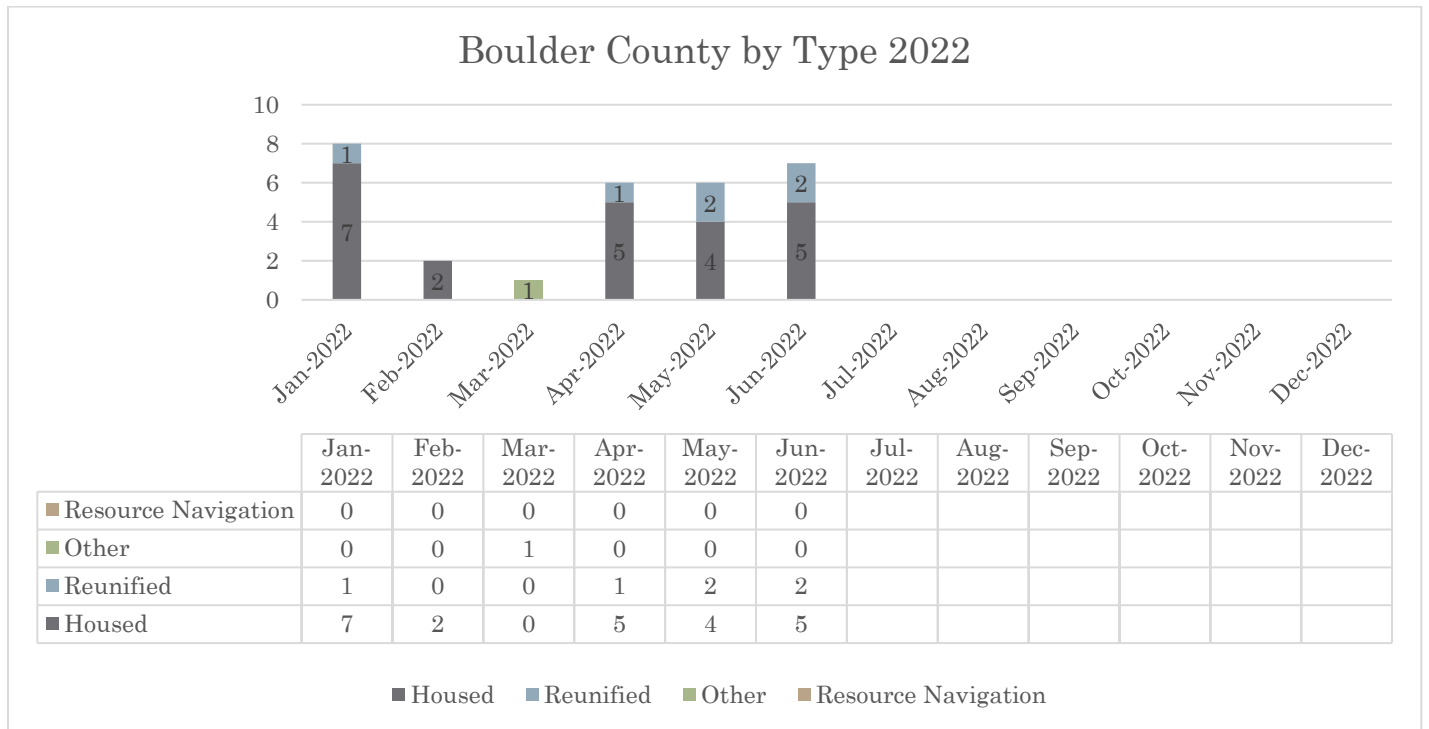
HOUSING OUTCOME BY EXIT TYPE CITY OF LONGMONT 2022

Since January 2022, in the City of Longmont, a total 32 individuals have exited homelessness with 18 (56%) individuals exited to housing, 13 (41%) through Reunification, and 1 (3%) through Other program.



HOUSING OUTCOME BY EXIT TYPE BOULDER COUNTY 2022

Since January 2022, through the OneHome HMIS data system and in Boulder County, a total 30 individuals have exited homelessness with 23 (77%) individuals exited to housing, 6 (20%) through Reunification, and 1 (3%) through Other program.

Boulder County Pathways to Housing Stability

Case Management Standards and Benchmarks

The Boulder County Pathways to Housing Stability (BCPHS) initiative, funded by a 5-year SAMHSA-TIEH grant, supports adults experiencing chronic homelessness who also have behavioral health needs in finding and maintaining stable housing. In early 2020, the BCPHS team convened a group of housing partners and providers to create and review case management standards to ensure consistent service provision and the highest quality of care for formerly unhoused clients as it relates to supportive services. A review of the existing literature revealed that no such standards existed across the country. As a result, in partnership with providers, the BCPHS team drafted case management standards which are reflected below. All providers have adopted these standards and incorporated them into their staff onboarding processes and supervision on a weekly basis. The benchmark components have also been incorporated in contracting throughout the county.

Goals of Case Management Standards



Program Participants Have Safe, Supportive Permanent Housing



Program Participants Achieve Greater Stability and Well-being

Benchmarks to Measure Success

1

Secure successful permanent housing as quickly as possible for participants.

2

Reduce participant recidivism to homelessness, incarceration, or hospitalization.

3

Increase stability of participants through employment, social engagement, and healthcare.

Guiding Principles for Case Management

- Meeting participants “where they are”
- Respecting participants’ autonomy and choice
- Case management approach is:
 - Trauma Informed
 - Participant-Centered
 - Strengths-Based
- Focusing on self-care, appropriate boundaries with participants, and sustainability of the program
- Focusing on collaboration, teamwork, and coordination with community partners
- Encouraging self-reliance, decision making, and personal responsibility of participants

Case Manager Actions and Tools

- Home visits/case management contacts to homes
- Case/goal planning that is attuned to acuity of need and ability to participate in goal setting
- Support in obtaining and maintaining public benefits
- Support in communication/problem solving with landlords
- Facilitating linkages to healthcare, mental health appointments, and other behavioral health services
- Promoting harm reduction
- Motivational interviewing
- Facilitating ongoing communication and coordination with all service providers
- Identifying social and emotional supports
- Celebrating successes
- Consideration of cultural context as identified by the participant
- Facilitating and encouraging participants in gaining independence from services, including graduation from the program



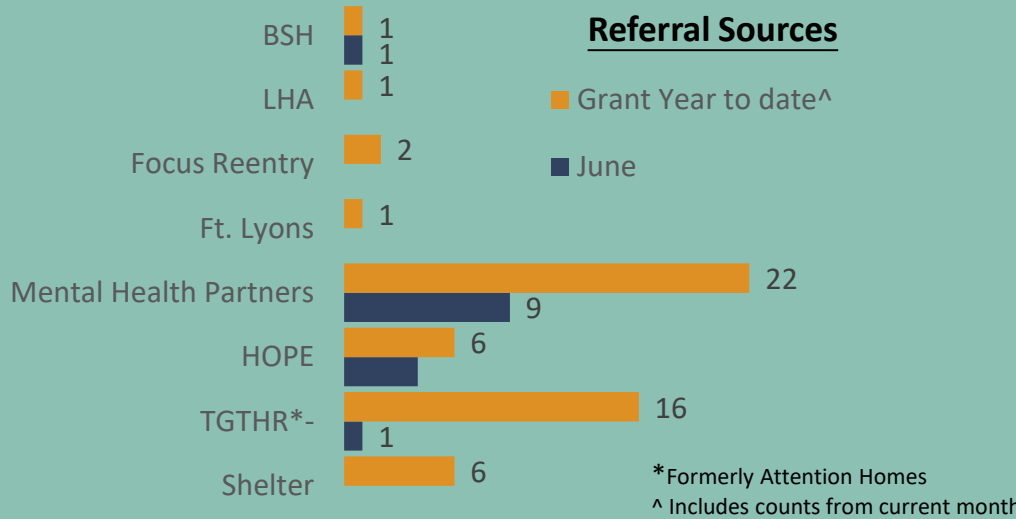
Boulder County Pathways to Housing Stability

June 2022 County Data Report

The Boulder County Pathways to Housing Stability (BCPHS) initiative, implemented by Mental Health Partners of Boulder County (MHP) supports adults experiencing chronic homelessness who also have behavioral health needs in finding and maintaining stable housing. There were 15 new referrals for June 2022. All data are from baseline/intake assessments.

Referrals

Clients are **referred** to BCPHS from external community services as well as internally within MHP. Referred clients are **screened** for eligibility into the program. Clients may then be **enrolled** if they fit the eligibility criteria.



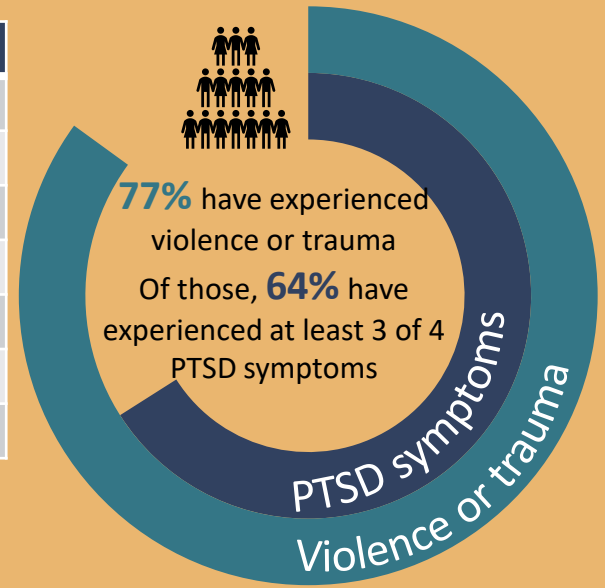

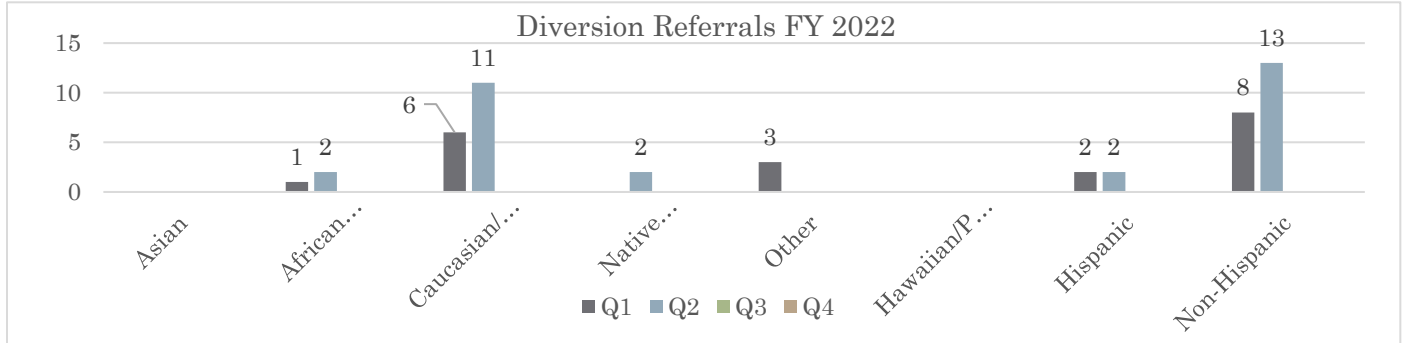

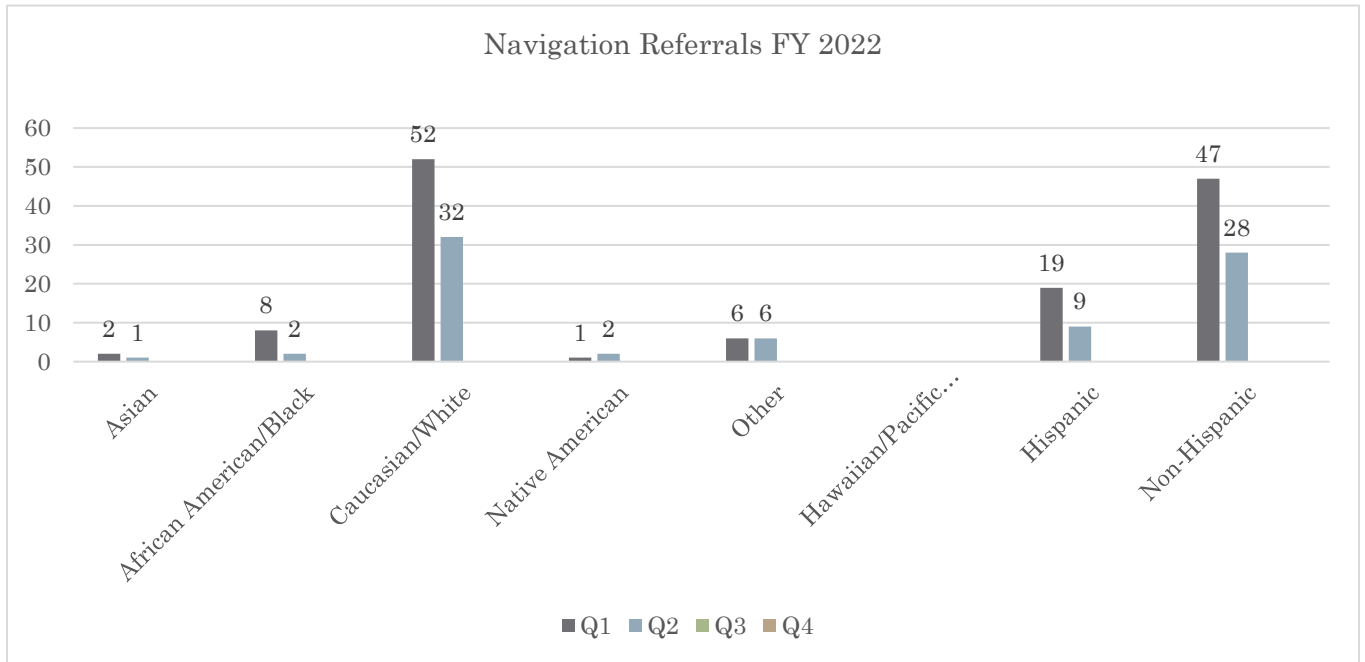

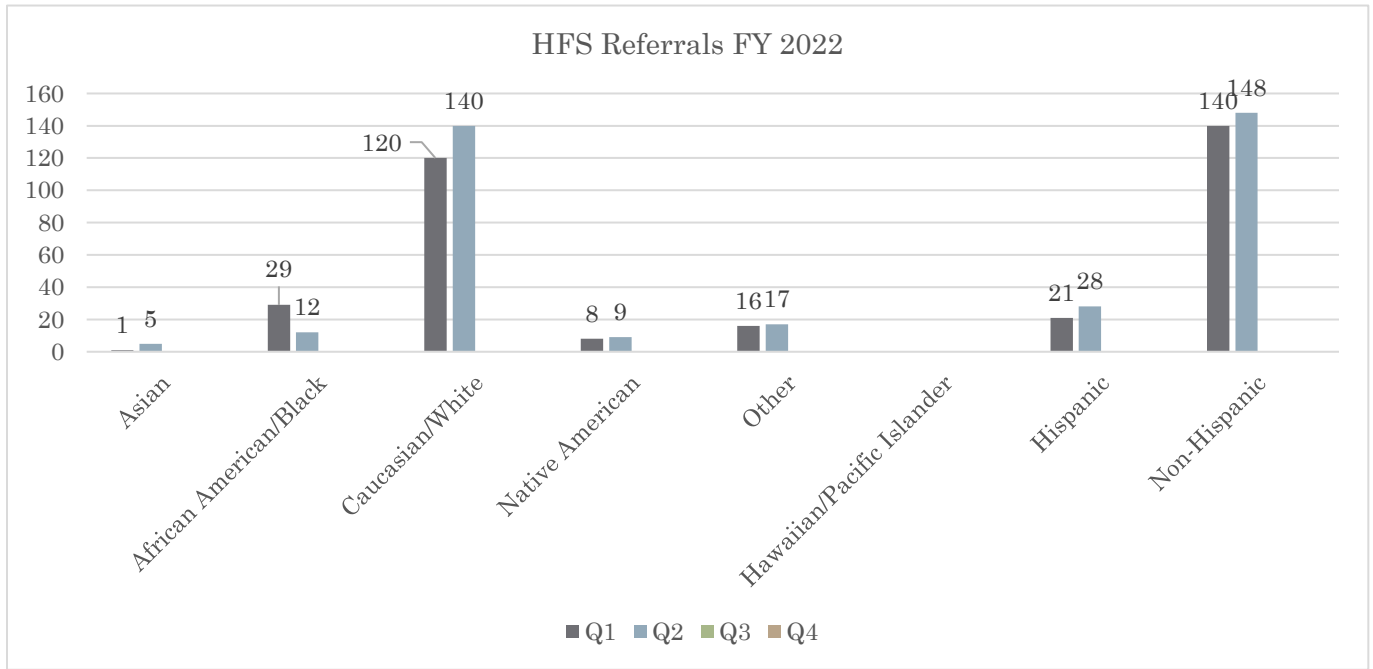
