    - a. Forum prefers one March meeting, but later in the window of dates to provide Forum members more time to receive materials in advance and ask questions about the agenda packet and get answers prior to attending the Forum meeting.

  - 1. Proposing scheduling regularly occurring Forum meetings every other month or quarterly, and continue TAC meetings monthly
