

ADDENDUM #1 Public Works Surveying Services for Northeast Corner of 71st Street and Lookout Road RFP # 7431-23

1. Question: We are a continuing services consultant in mechanical, electrical, lighting, building envelope assessments and commissioning services and our firm also offers land surveying services. Are we able to submit a response to this RFP?

ANSWER: Yes.

2. Question: Utility locates. Does Boulder county what level A or B quality for this project?

ANSWER: Quality level B is acceptable.

 Question: Title commitment reports or ownership and encumbrances (O&E) reports for at least two private property. Do we need to include this in our bid? Are you requiring them?

ANSWER: This is not needed.

4. Question: Do you want to use drone/lidar for topographic data that is on private land? Or would you prefer boots on the ground?

ANSWER: Physical survey on site.

5. Question: Construction staking – what exactly are we staking? We have construction services in our company can we include this with our proposal?

ANSWER: Staking will be used to show property owners the right-of-way lines. Only survey is needed at this time.

6. Question: Civil 3D files – will you accept .XML files for the surface? Is one foot contours needed?

ANSWER: Please provide a Civil 3D/AutoCAD .DWG drawing file and PDF which shows the topo survey and the project control with one-foot contour intervals. Reference Exhibit C, CAD/Survey Standards & Deliverables.

7. Question: We also have potholing services in our company. Do you need pricing for this service?

ANSWER: Yes.

8. Question: Are you expecting costs for legal descriptions and exhibits for land acquisition and easements? If so, how many should we estimate for?

ANSWER: No.

9. Question: How many trips should we plan on for construction staking?

ANSWER: Plan for two trips.

10. Question: Do you expect signed and sealed SUE drawings?

ANSWER: No.
