

ADDENDUM #1 Public Works - Road Maintenance Rental Equipment BID # 7428-23

The attached addendum supersedes the original Information and Specifications regarding BID # 7428-23 where it adds to, deletes from, clarifies or otherwise modifies. All other conditions and any previous addendums shall remain unchanged.

1. Question: I'm currently working on getting proposal submitted. What general equipment needs to be included on the line cards If you could please be as specific as possible, that would be great.

ANSWER: Generally, we rent heavy equipment, pumps etc. The more you include the more opportunity we have to rent from your company.

2. Question: We have questions on the following of the Boulder County Sample Contract:

<u>Section 8 Schedule of work</u> – Please expand on this description and its meaning. If it is referencing usage of our machines, we allow weekly and monthly rentals. 1 week of rental is equal to 7 days and 1 month of rental is equal to 28 days of machine use. The allowable hours for 1 week of rental is up to 40 hours of machine usage and 1 month is up to 176 hours of machine usage. Would this be acceptable to the county?

ANSWER: Yes. With regard to the "schedule of work" piece of the question, we can strike that entire paragraph from the contract. It generally applies to situations where work is being done on behalf of the County, and we need

some control over when/how the work is performed to minimize impact on operations. That is not the case here.

<u>Section 43C Insurance Obligations of County</u> – Can you provide a copy of the Boulder County standard-maintained insurance coverage for our review to make sure there is acceptable coverage for all of our equipment that we are bidding.

ANSWER: The insurance requirements for this Bid are on the Insurance and W-9 Requirements Page of the Bid Document. PDF Page 7.

<u>Section 43D Deductible</u> – If equipment is damaged by the Boulder County would any deductibles that are on the coverages be covered by Boulder County?

ANSWER: Section 43 d is for the vendors insurance requirement as part of this contract. The county would be responsible for covering any damage caused by the county to the equipment.
