The attached addendum supersedes the original Information and Specifications regarding SOQ # 7472-23 where it adds to, deletes from, clarifies or otherwise modifies. All other conditions and any previous addendums shall remain unchanged.

ATTENTION:

- **The submittal due date has been extended. The new submittal due date is on or before 2:00 p.m. Mountain Time on July 10, 2023.**
- **There is a new Updated Pricing Schedule – Excel document attached separately.**

1. Question: At some locations there are backflow devices listed that don't exist and others there are more backflow devices than are listed. How am I to bid?

ANSWER: We have gone over the Pricing Schedule and compared it to the documents that were provided by our maintenance technicians and found some ambiguous entries. We have amended the Pricing Schedule for Catamaran Court and Regal Square to indicate that there are fire sprinkler systems requiring backflow certifications and annual fire sprinkler testing. Please adjust your submissions and if you have any questions about any apparent ambiguities, please note those in the submission and those will be resolved prior to contracts being awarded.

2. Question: Catamaran Court shows no fire sprinkler systems, however there are 4 buildings with a fire sprinkler system.

ANSWER: Pricing Schedule has been amended to show that fire sprinkler backflow certifications and annual inspections are necessary at this property.

3. Question: Regal shows no fire sprinkler systems, however there are 3 buildings with a fire sprinkler system in each.

ANSWER: Pricing Schedule has been amended to show that fire sprinkler backflow certifications and annual inspections are necessary at this property.

Boulder County does not accept responsibility under any circumstance for delayed or failed email or mailed submittals.
