NOTE WORTHY UPDATES FOR MAY 2023

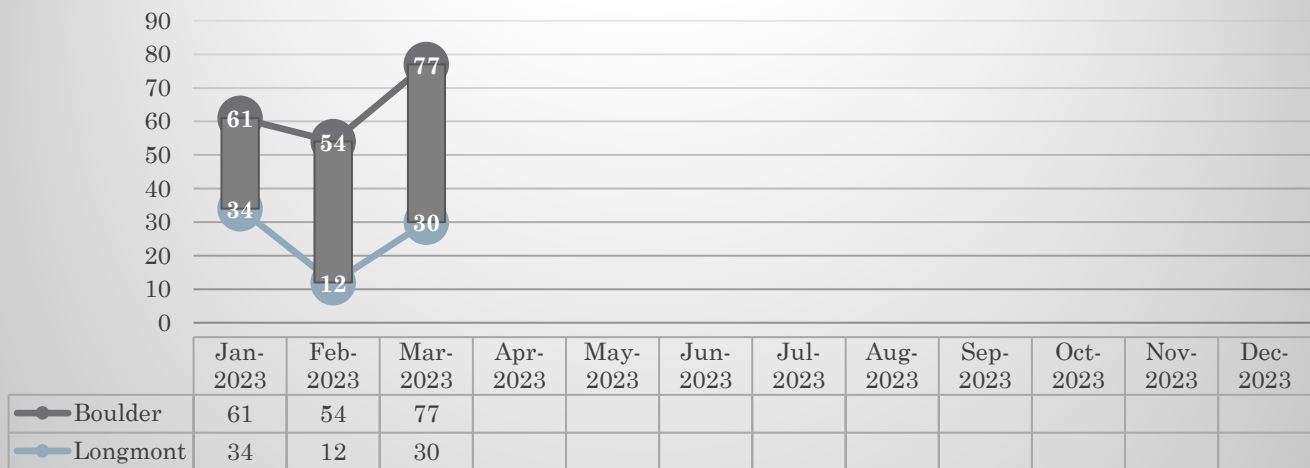
- HSBC continues to work on the Annual Report for 2022.
- Department of Housing released recommendations for first round of funding in response to Transformative Homeless Response Notice of Funding Opportunity.
- Racial Equity Data for Quarter 1 2023 can be found in the supplemental data attachments.
- HSBC has been certified as in the Final Mile for Homeless Veterans work.

OVERVIEW OF DATA IN BRIEFING

- Overall, the number of Coordinated Entry screenings were higher in March 2023 compared to the same time frame in the prior year (2022).
 - City of Boulder increased by 25% in March 2023 and increased 10% annually.
 - City of Longmont increased by 17% in March 2023 but is decreased by 16% annually.
- 94 (35% exit outflow) individuals have exited homelessness since January 1, 2023, (an overall increase of 5% compared to the same timeframe as last year).
 - City of Boulder saw an increase of 33% in all exit avenues:
 - Housed- 32% increase for the calendar year
 - Reunification-24% increase for the calendar year
 - Other- 100% increase for the calendar year
 - City of Longmont saw an increase of 21% in all exit avenues:
 - Housed- 40% increase for the calendar year
 - Reunification- 20% decrease for the calendar year
 - Housing exits through HMIS data system saw a 9% decrease overall all for the calendar year.
- On average, 31 individuals exit homelessness per month for calendar year 2022:
 - 23 to housing
 - 8 through reunification
 - 1 through other programming such as treatment or rental assistance for Diversion services.

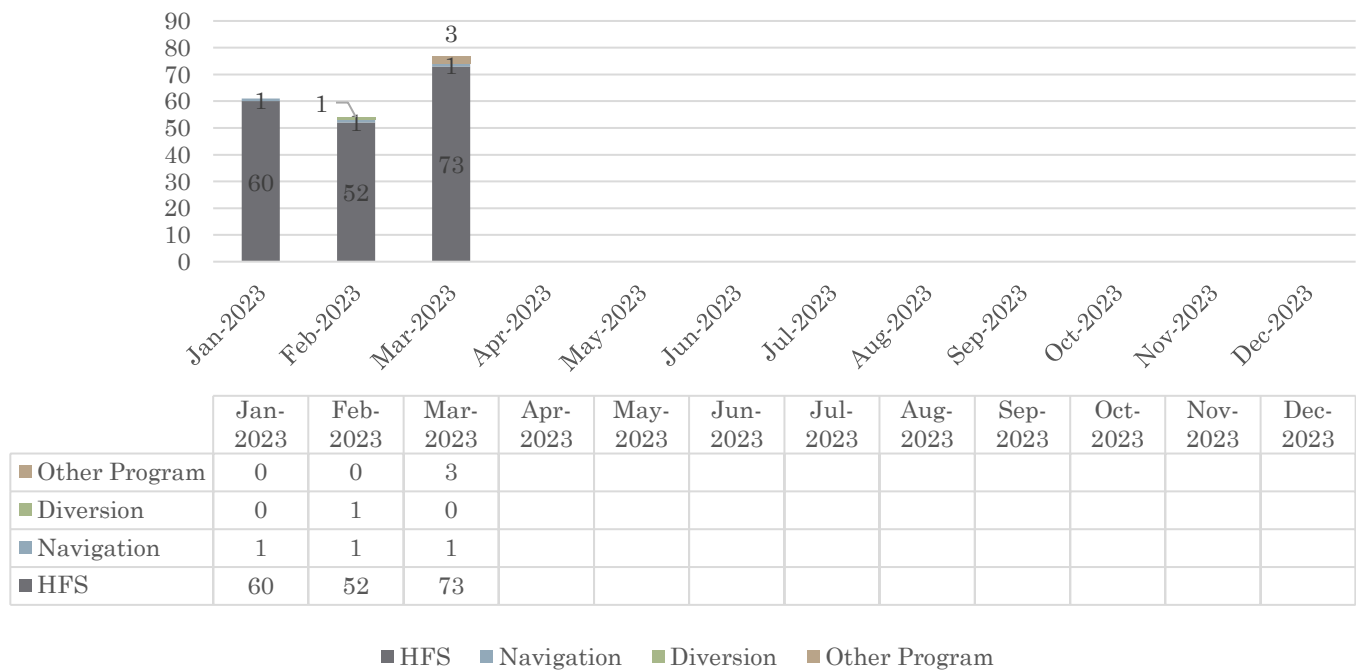
Coordinated Entry Screenings FY 2023



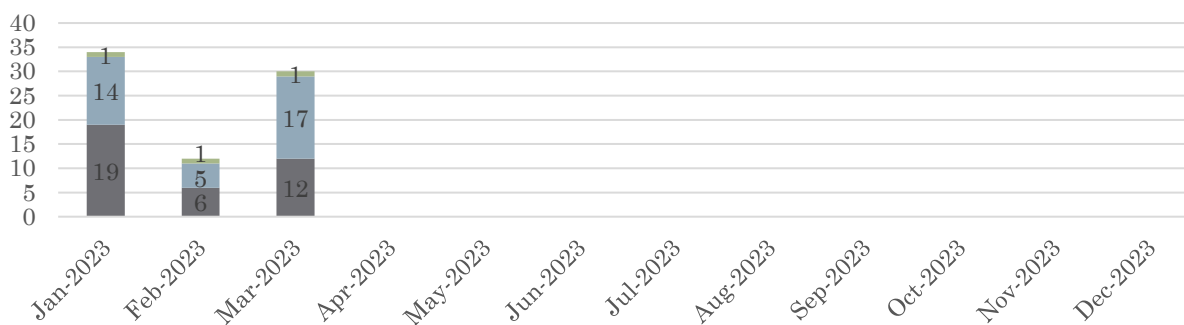
COORDINATED ENTRY ASSESSMENT RESULTS PER LOCATION

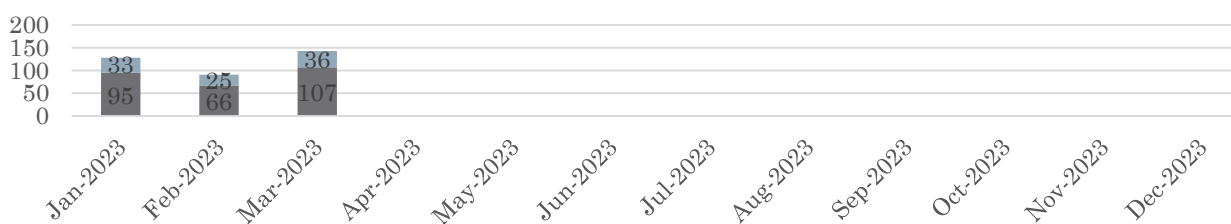
HOUSING OUTCOMES

The following data and charts reflect individuals experiencing homelessness who have exited the homeless services system to a stable housing outcome. ***It is important to note that the data reflected in the following charts reflect Housing Outcomes via system entry and exit are not the same individuals.***

SYSTEM ENTRY/EXIT APRIL 2023

Since January 2023, 35% (94¹) exited homelessness into a stable housing situation.

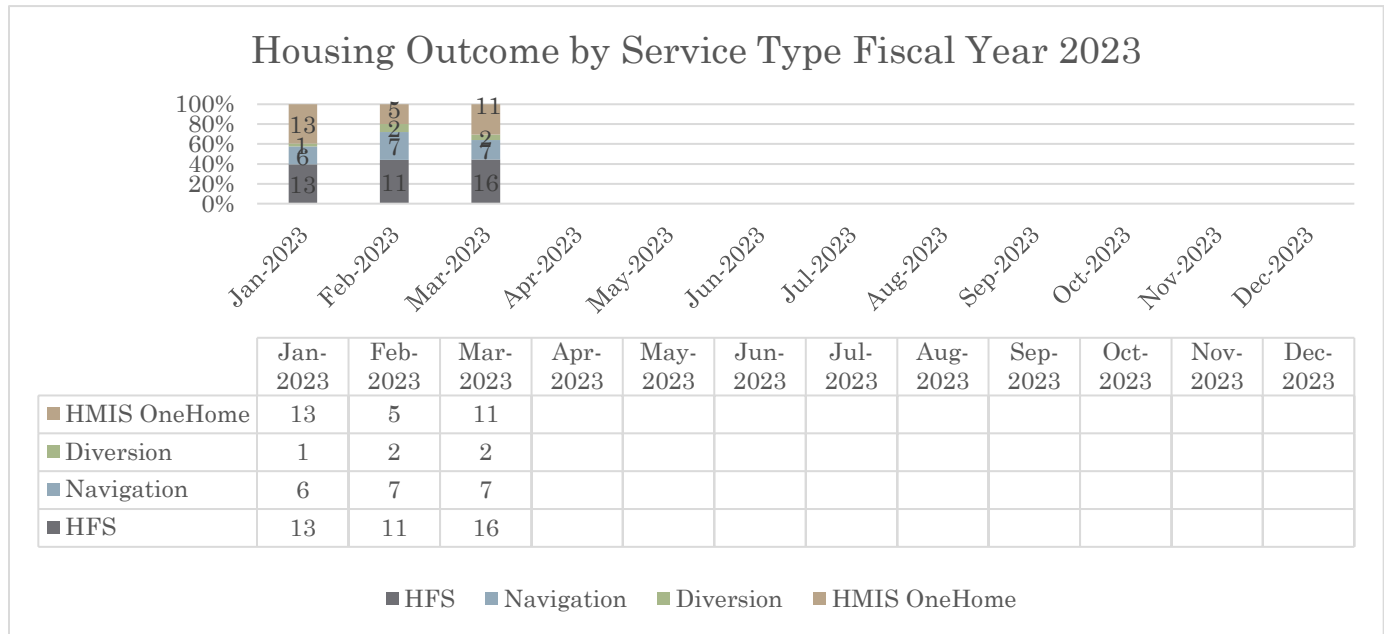

HOUSING OUTCOMES FISCAL YEAR BY COORDINATED ENTRY INITIATED SITE 2022

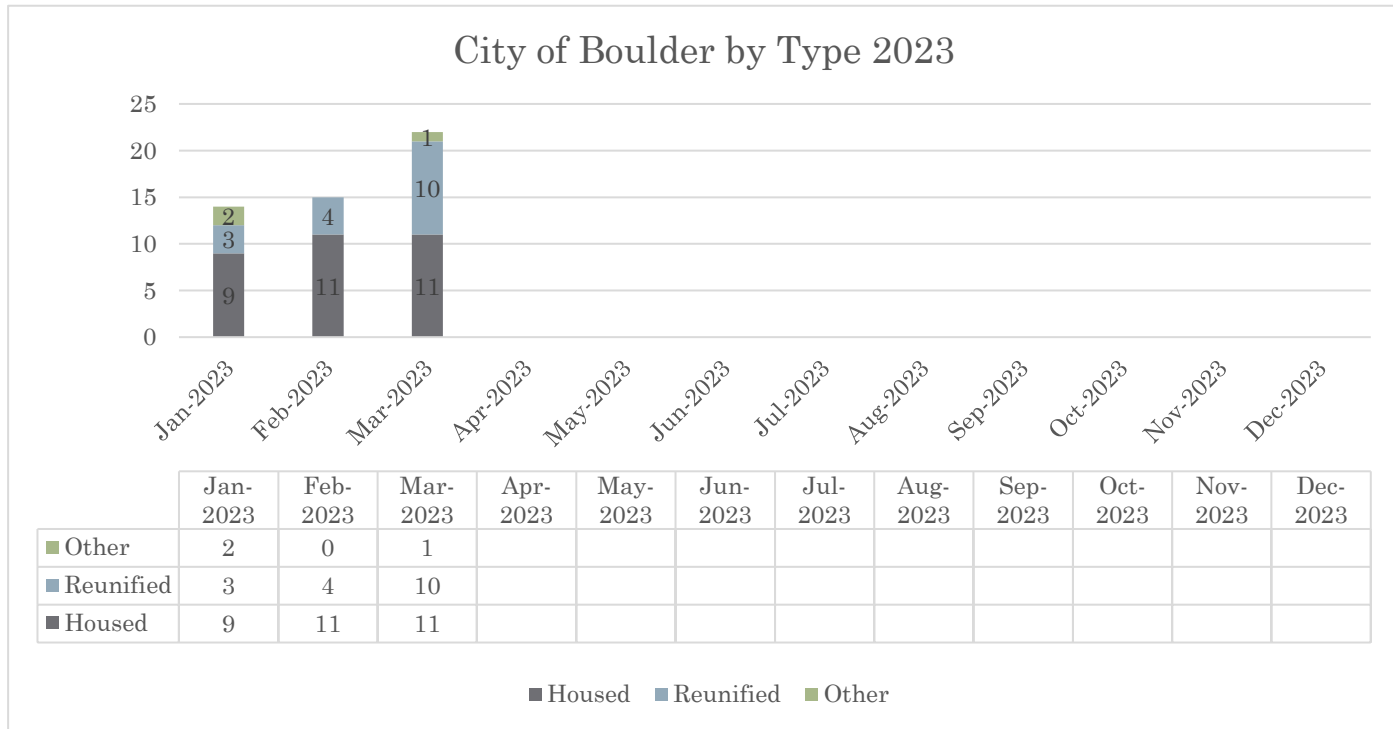
As reflected, a total of 94 individuals experiencing homelessness exited homelessness since January 2023 with 51 (54%) from the City of Boulder, 14 (15%) from the City of Longmont and 29 (31%) Boulder County².

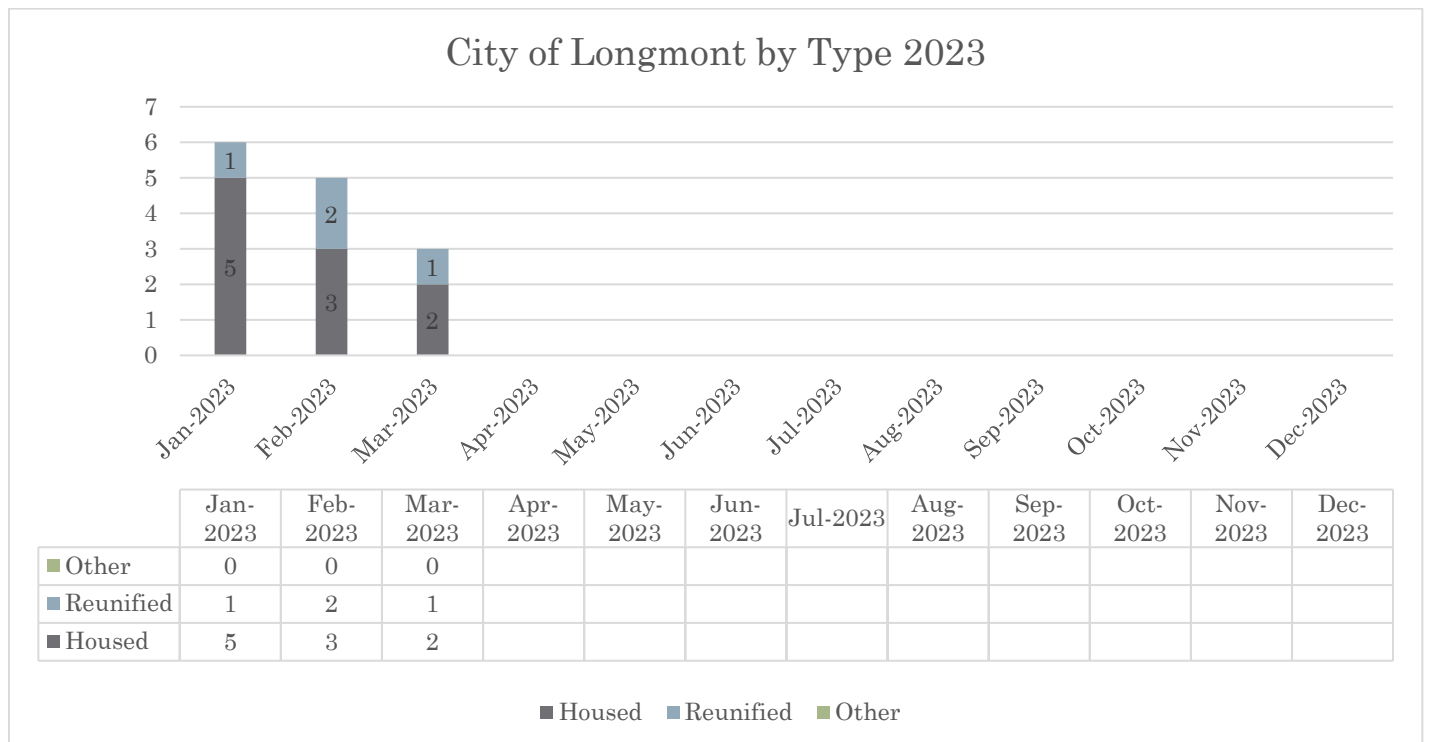
HOUSING OUTCOME BY EXIT TYPE CITY OF BOULDER 2023

Since January 2023, in the City of Boulder, a total 51 individuals have exited homelessness with 31 (61%) individuals exited to housing, 17 (33%) through Reunification, and 3 (6%) through providing rental assistance (reflected in Other) to remain in housing.



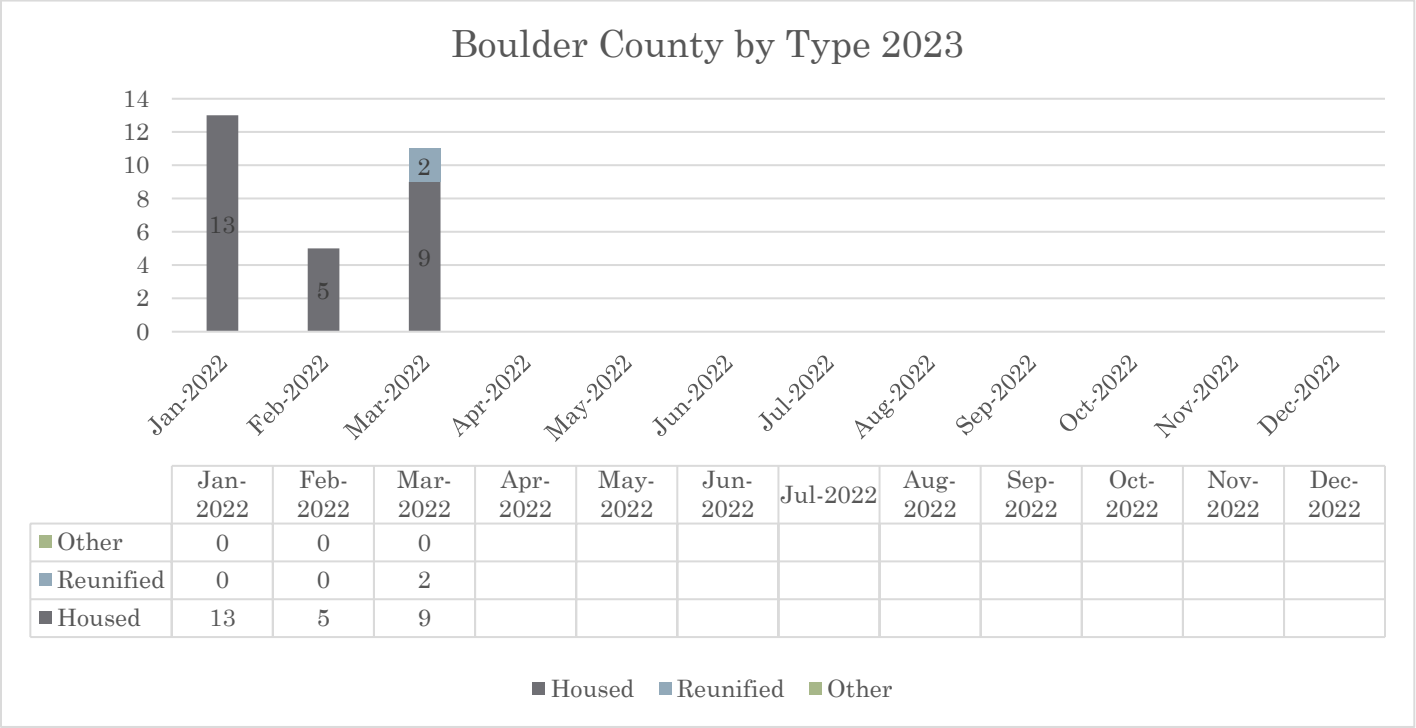
HOUSING OUTCOME BY EXIT TYPE CITY OF LONGMONT 2023

Since January 2023, in the City of Longmont, a total 14 individuals have exited homelessness with 10 (71%) individuals exited to housing, and 4 (29%) through Reunification.



HOUSING OUTCOME BY EXIT TYPE BOULDER COUNTY 2023

Since January 2023, through the OneHome HMIS data system and in Boulder County, a total 29 individuals have exited homelessness with 27 (93%) individuals exited to housing and 2 (7%) exited through reunification.

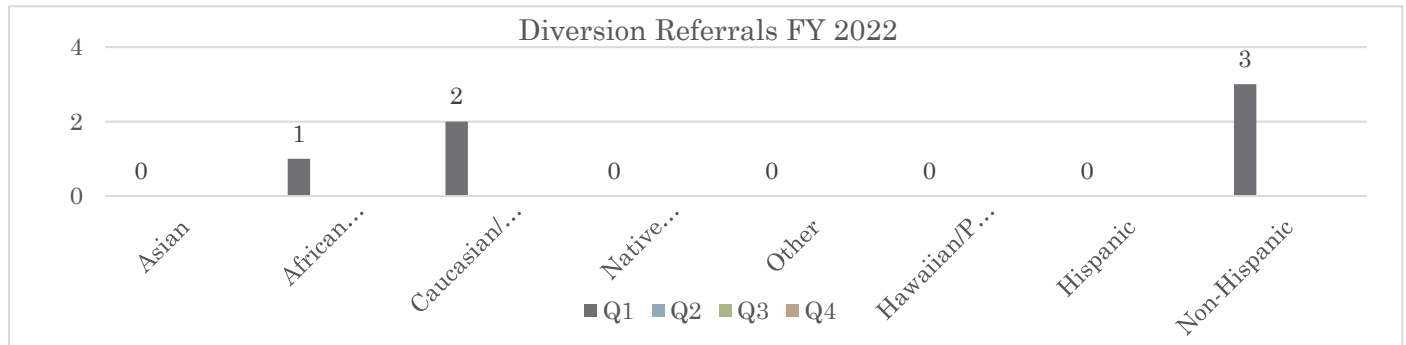

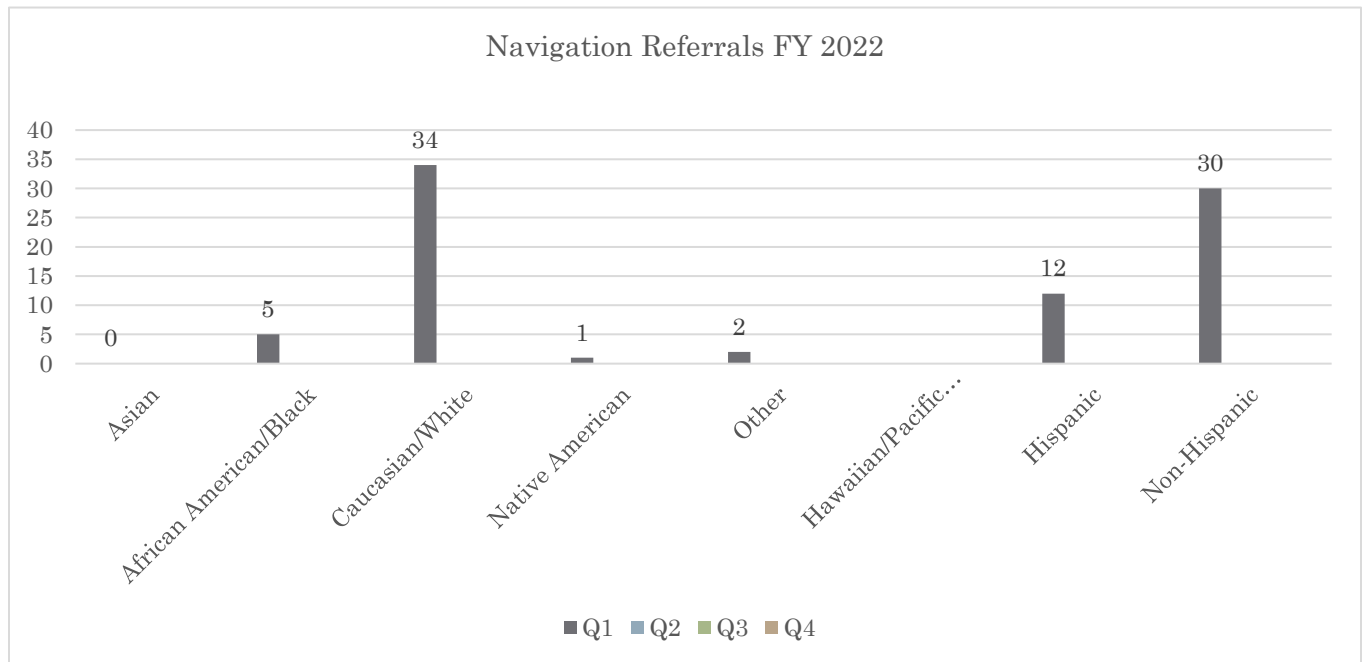

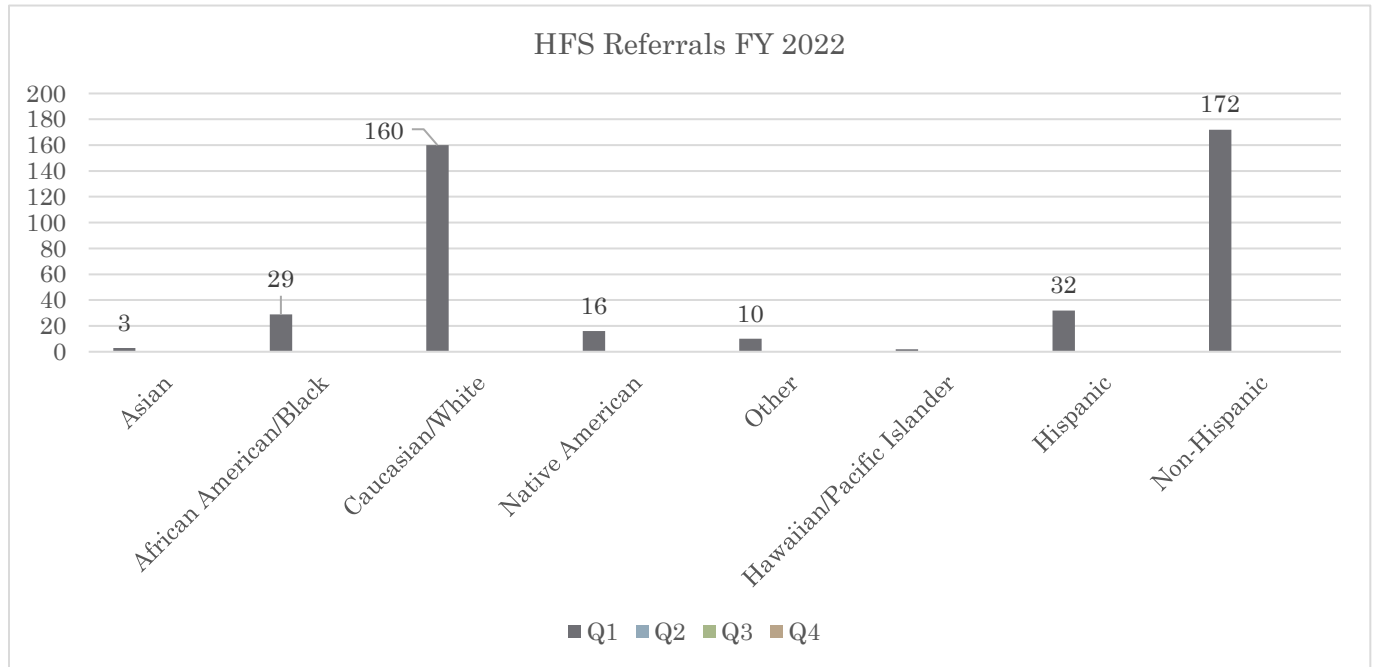

Boulder County Pathways to Housing Stability

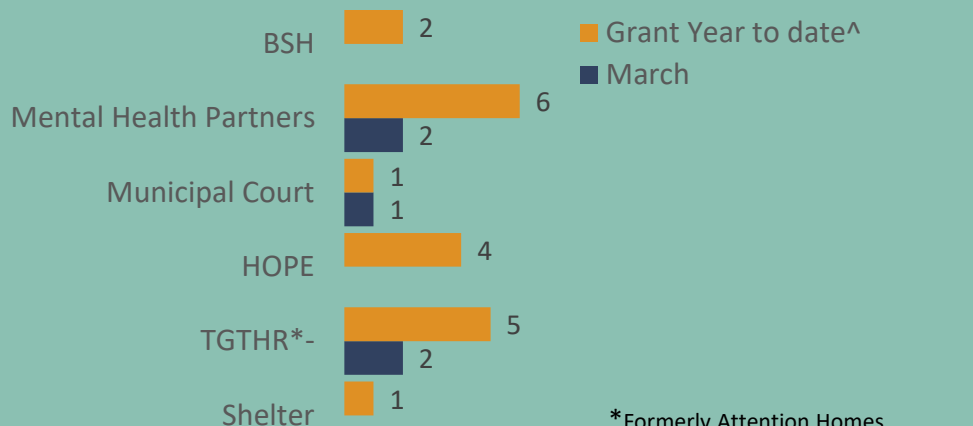
March 2023 County Data Report

The Boulder County Pathways to Housing Stability (BCPHS) initiative, implemented by Mental Health Partners of Boulder County (MHP), supports adults experiencing chronic homelessness who also have behavioral health needs in finding and maintaining stable housing. There were 5 new referrals for March 2023. All data included in this report are from baseline/intake assessments.

Referrals

Clients are **referred** to BCPHS from external community services as well as internally within MHP. Referred clients are **screened** for eligibility into the program. Clients may then be **enrolled** if they fit the eligibility criteria.

Referral Sources



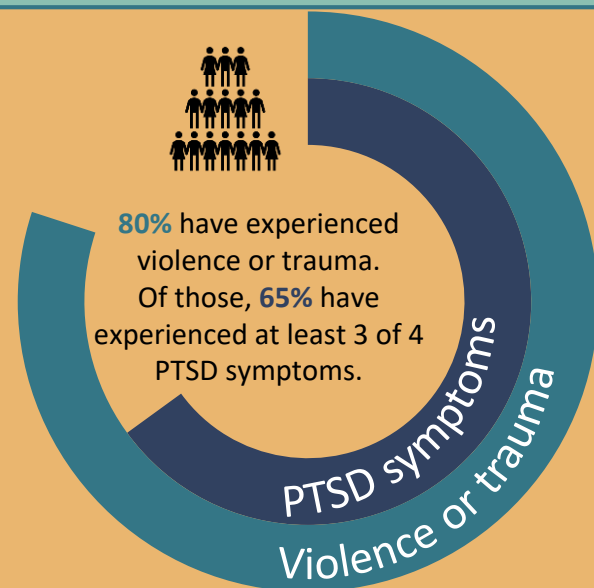

\$6.5M awarded across all partners
 - Boulder County HSBC - increasing capacity for HSBC staff, bridge housing funds and support for mountain outreach
 - Housing and Human Services – targeted towards family homeless response, bridge housing, reimagine the housing help line and create a centralized family coordinated entry response
 - City of Boulder - \$2M for respite facility
 - Other Awards - Boulder Shelter for the Homeless & Mental Health Partners
 - Pending – HOPE, Focus Reentry, Mother House
- Behavioral Health Administration HB22-1281 – Community Investment Program
 - BHA - \$600K to compliment \$300K to purchase another recovery home
 - Significant outpatient and recovery services through Red Point
- Substance Abuse and Mental Health Services Administration (SAMHSA) Treatment for Individual Experiencing Homelessness (TIEH) Submission
 - Reboot of current grant for case management services

Next steps: HSBC take the lead, put out an Request for Proposal (RFP), Jim will take on developing evaluation questions with the first step at the Policy Implementation Team meeting.

- Future Opportunities for Crisis Stabilization and Treatment
 - Growing opportunities for crisis stabilization and treatment. BOCC, the District Attorney, and HSBC have prioritized adding recovery homes to the portfolio of services.
