

ADDENDUM #1

Housing & Human Services Boulder County Housing Authority Regal & Geneseo Apartments Balcony/Exterior Stair and Siding Repairs BID # 7509-23

Note - A substitution request has been submitted per Section 00 41 04 of the bid documents. The request has been approved; TimberTech may be substituted for Trex. This approval is for the submitted request only, all vendors must submit their own substitution requests.

 Question: Please let me know if you're considering extending the submission date. This is an unrealistic timeframe for quality submissions for this scale of project.

ANSWER: We appreciate the feedback; at this time we are not considering extending the submission date.

2. Question: I wanted to get more information about the day final of the BID and if the quote you want only labor or also materials to carry out the entire project as such, any information you can give me I will be very grateful. Thank you for your time.

ANSWER: Boulder County Housing Authority is currently seeking contractor bids to perform exterior work at two separate BCHA properties.

The first bid requested is for Regal Ct in Louisville, CO 80027. This is a 12 building, 34-unit property in need of estimates for requested exterior work. The scope of work here for all buildings will include siding, trim and WRB replacement on all buildings, roof intake exhaust added on all buildings, new windows added throughout, new sliding glass doors added throughout, decking repairs as specified in engineering report, balcony and patio repairs as specified in engineering report, stair, and landing repairs as specified in engineering report. Engineered drawings have been provided for entire scope of work.

The second bid requested is for decking repairs at 503 and 505 W Geneseo Lafayette, CO 80026. There are two buildings with 4 exterior decks in need of work included in this scope. Decking work here will include removal of existing composite decking at balconies, cleaning, and new decking added as indicated, demo and replacement of framing and deteriorated wood on one deck, repainting of all decking, and all repairs indicated in engineering report.

Final bids for both projects will be due September 14, 2023.

Quotes should include both labor and materials.
