## Renewals and Initial registrations via drop-box

If you need to complete a registration renewal or a first-time registration, we can process these transactions via one of our external drop-boxes.

Registration renewal: Please place the following in a sealed envelope into the drop-box

- Completed cover letter
- Renewal postcard (or completed collector's item renewal letter)
  - Notice on your postcard if an emissions test or proof of insurance is required
    - If so, please include with paperwork
- If you don't have your postcard, please write your license plate number on the cover letter
  - o If you are unsure if an emissions test is due, please call us at 303-413-7710
- Check made to Boulder County
  - o Late fees are due after the grace period- \$25 per month or \$100 max
    - Trailer late fees are \$10

**Initial Registration:** If you just bought a car and are plating it for the first time, please include the following in a sealed envelope in the drop-box.

- Completed cover letter
- Title complete notice
- If you didn't receive a title complete notice, but are sure the vehicle has already been titled on your name, please include the vin number for the new vehicle on the cover letter
- Passing emissions test, if required
  - o Gas vehicles more than 6 years old
  - o Diesel vehicles 4 years old or older
- Proof of insurance

Once received, please allow 3 business days to complete. We will call to collect payment if a check isn't included. There is an extra fee to use a card.
