Boulder County Communications Hardware & Network Requirements for Mobile CAD as of July 3, 2024

Expectations:

Boulder County Communications (BCC) can provide Mobile CAD connectivity to enhance operations. User-Agencies are required to comply with all BCC procedures for the implementation, use and ongoing maintenance of mobile CAD. BCC user-agencies interested in building mobile CAD connectivity capacity shall notify BCC technical staff via submitting a ticket and work collaboratively throughout implementation. BCC dispatches Career FDs by apparatus and Volunteer FDs by agency. CAD connectivity can enhance information exchange but does not change standard dispatching processes.

User-Agency Hardware and Connectivity Requirements:

- 1) Dedicated Internet circuit supplied by the User-Agency
 - a. 10MB minimum
 - b. A single forward facing static IP address is required
- 2) Firewall to broker the connection between the Fire Station and BRETSA
 - a. Must support IKE2 at a minimum
 - b. Must be able to establish an encrypted VPN tunnel between the User-Agency Firewall and the BRETSA Firewall
- 3) Mobile Data Computer or Tablet
 - a. 1.66GHz Processor
 - b. 4 GB RAM
 - c. Disk Space: 12 GB
 - d. Monitor 1024 x768 minimum resolution
 - e. Operating System: Windows 10; 64 bit
 - i. NOTE: Window 11 is NOT supported at this time
 - f. Maintain current Anti-Virus software installed that is regularly scanning the device
 - g. Maintain current Windows updates on the Mobile Data Computer
 - h. Ensure all emergency patches for zero day exploits are applied as soon as they are available
 - i. A ruggedized Mobile Data Computer or Tablet is highly recommended
- 4) Connectivity from the Apparatus or Mobile Data Computer (MDC) back to the User-Agency Firewall at the Fire Station
 - a. Cellular service for each MDC
 - b. Wireless connectivity from the MDC to the Fire Station Firewall
 - i. If connecting the MDC to the Apparatus, a mobile router is needed to manage the cellular connection between the Apparatus and the Fire Station


- ii. Cradle Point and Sierra Wireless are two common options for a mobile router. Each offers automated switching between multiple carriers, connection persistence, and a wifi hotspot. Additional carrier charges will apply
- c. A Mobile Firewall to establish a secure tunnel between the MDC and the Fire Station Firewall
 i. NetMotion is commonly used for this
- d. If connecting directly from the MDC to the User-Agency Firewall, a cellular connection must be established from the MDC to the User-Agency Firewall
