

Q1 Previous to this survey, were you aware that Boulder County provides mosquito control in your area?





Q2 Of the methods described above, which would you prefer be used in your neighborhood?





Q3 Based on your experience with mosquitoes in your neighborhood, what kind of mosquito control would you like in your area?







Q5 Boulder County property assessments for residential properties in the BCMCD currently include an annual fee of \$33 for mosquito control. Is this amount:





Q6 If additional mosquito control services (larval or adult) were provided, would you support increasing the assessment amount?





Q7 If additional mosquito control were provided, what method would you prefer?






