Question: What is expected of being informed? Does "one stop operator" bring new opportunities to the board?

ANSWER: Research partnerships that may require MOU's based on WIOA legislation. There is potential the One Stop Operator could recruit new board members, but it is not required. We have internal processes for this.

2. Question: What is the definition of " regular?" Once a week, month, quarter, contract period? (4.1)

ANSWER: This is done quarterly for the duration of the MOU.

 Question: What does "able to fill any Service Gaps identified by the BCWDB? (4.2)

ANSWER: If there are service gaps related to our MOU partners, we will convene partners to address the issue and/or identify other partners within the community that can provide the service.

4. Question: What guidance from the BCWDB mean? (5.1)

ANSWER: The Boulder County Workforce Development Board (BCWDB) and the Work Force Boulder County (WfBC) Director will provide guidance on how to conduct the annual meeting.

5. Question: What is the duration of the meeting?

ANSWER: It varies and is dependent upon the needs of the Boulder County Workforce Development Board (BCWDB), Work Force Boulder County (WfBC) Director, and the Partner.

6. Question: Is the meeting content to be each partners performance to the MOU, or an aggregate of performance?

ANSWER: Each partner.

7. Question: How many contracts/MOU

ANSWER: There are currently 8 MOU's.

8. Question: How long and what is the frequency of the Partners?

ANSWER: It varies and is dependent upon the needs of the Boulder County Workforce Development Board (BCWDB) and the Work Force Boulder County (WfBC) Director, and the Partner.
