Extra Help** LIS (Low-income subsidy) for Medicare Prescription Drug Plans	Program pays Part D premiums up to \$46.59 per month and eliminates drug deductibles. Copays are reduced according to Medicaid type and income.	Individual: \$17,010 Couple: \$33,950	Individual: \$1,903 Couple: \$2,575

**Income limits for Extra Help are for screening purposes. Asset limits include \$1,500 per person burial allowance. Countable assets do not include the home, personal vehicle, burial plots, or personal possessions.
