# QUESTIONS AND ANSWERS RFP 102-24 - ADDENDUM #1

- 1. Question: There are three important conferences (COSA, SCW, CASFM) in the next two weeks that many members of our multi-disciplinary teams will be attending. With this in mind, would you consider moving the proposal submittal deadline to a later date?
  - Answer: Yes, the proposal submittal deadline will be changed to October 15, 2024, at 2:00 p.m.;
     MDT.
- 2. Question: Should the Consultant include scope for attending public outreach events or preparing exhibits/presentations for them?
  - Answer: The required scope is already included in Task 8 Presentation of Design.
- 3. Question: Should the Consultant include Boulder County Permit fees, or will they be paid separately or waived?
  - Answer: Do not include Boulder County permit fees in your proposal.
- 4. Question: Should the Consultant include Boulder & Weld County Ditch review fees, or will they be paid separately?
  - Answer: Do not include Boulder & Weld County Ditch review fees in your proposal.
- 5. Question: In addition to LiDAR, does existing available mapping from BCPOS include any previously completed ground survey?
  - Answer: BCPOS has aerial drone video footage of the site, however we do not have LiDAR or
    existing ground survey data. Drone footage of the site can be accessed from the <u>East Boulder</u>
    Creek Management Plan website.
- 6. Question: Can you clarify cattle crossing in the vicinity of 287 (Tactic #7), are you wanting crossing ability under 287, and across Boulder Creek to access north/south parcels?
  - Answer: The cattle crossing will be to give cattle the ability to access the north/south parcels. The location depicted on the site plan is the proposed location for this crossing.

#### <u>Additional Information:</u>

The selected Contractor will be required to complete the design and submit construction documents of the Southwest Cluster first as BCPOS expects to complete and open the park to the public before the end of next year, 2025. The Northwest Cluster (which includes Boulder Creek and Coal Creek stream restoration) design completion will still be required to be due by July 31, 2025, as planned. Therefore, Contractors are advised to assign the appropriate resource allocation and structure fee schedule accordingly.
