## ANNUAL ENROLLMENT PERIOD: NOVEMBER 1–JANUARY 15

**OMNISALUD IS A PROGRAM THAT PROVIDES UNDOCUMENTED INDIVIDUALS LIVING IN COLORADO WITH A FULLY SECURE AND CONFIDENTIAL ONLINE PLATFORM TO OBTAIN LOW-COST\* OR REGULAR-COST HEALTH COVERAGE.**

**Regular-Cost OmniSalud:** Offers health plans at market prices for those with an income above 150% of the poverty line who do not qualify for the low-cost option.

**Low-Cost OmniSalud:** Offers reduced-cost health plans for those with an income below 150% of the poverty line.

**\*Enrollment for the low-cost option is limited.**

**Colorado Connect:** Is the online platform where individuals can enroll in the OmniSalud program. Colorado Connect is part of the Connect for Health Colorado system.

### 2025 ENROLLMENT PROCESS

#### November 1—22: Re-enrollment period for individuals currently enrolled in a low-cost OmniSalud plan.

All individuals enrolled in a low-cost OmniSalud plan will have the opportunity to re-enroll if they wish to remain in the program next year. To do so, they must complete the entire enrollment process during the re-enrollment period (the system will automatically flag applications as eligible for re-enrollment once complete). To re-enroll, log in to your account, complete a new application, and choose a health plan. Please note that you must meet the income requirements to re-enroll in a low-cost plan.

#### November 25 (starting at 8 a.m.)—January 15: Enrollment period for low-cost OmniSalud plans open to the general public, until all available spots are filled

Once the low-cost spots are filled, the regular-cost option will continue to be available until January 15.

### NEW COVERAGE OPTIONS FOR 2025

#### Connect for Health Colorado for DACA recipients

Starting November 1, 2024, DACA recipients will be able to access the health plans and benefits available through Connect for Health Colorado. During the general enrollment period (November 1—January 15), DACA recipients enrolled in an OmniSalud plan must complete their enrollment for the following year through Connect for Health Colorado.

#### Medicaid for Undocumented Coloradans

Starting January 1, 2025, undocumented pregnant individuals and undocumented children (ages 0–18) living in Colorado, including DACA recipients, will be eligible to apply and receive all the services and benefits available through Health First Colorado (Medicaid) and CHP+. Individuals with DACA status who are 19 and older are not eligible for Medicaid and must enroll in coverage through Connect for Health Colorado.
