Director Updates - Nora Sáenz

Our local plan is progressing – it was submitted for public comment.

Sustainability new hire starts next week.

Behavioral Health is a focus.

Dara DiRito our Work-based Learning Program Coordinator, started.

<u>Presentation from Intrado</u> – Brittany Gratton, Sr. Director of Talent Acquisition & Development

Intrado serves public safety. Their vision is to save lives and protect communities. They were founded in 1979, and currently have about 1000 employees. They work with 911 emergency – they send location info to 911 call center. They work with all phone carriers. They have hardware and software for the 911 call center. They have services for business and schools. They are currently going through a culture change and seeking new hires – mainly software and customer support.

New Americans Presentation by Anthony Cherwinski, Global Talen Administrator, Office of New Americans

Office of New Americans established in June 2021. Their vision is that all new Americans have equitable access.

Who are new Americans? Immigrants (conscience decision to move), Refugees (forced to leave their country due to war), Asylum-seekers (seeking protection) and Migrants (relocate for economic reasons, ex. seasonal work). Refugees have work eligibility immediately upon arriving in the US.

New Americans – a more inclusive term would be Newcomer.

New Americans are usually highly educated and under employed.

Anthony showed a webinar about working with New Americans – Recruiting to Upskilling.

There are approximately 3000 school aged children in Boulder County that are New Americans. Approximately 40,000 have come through Denver in the last 2 years.
