### Project Name: Wildfire Partners Mitigation Specialist

#### Background:

Launched in 2014, Wildfire Partners is Boulder County's wildfire mitigation program. The program began in western Boulder County. In 2022 and 2023, we started our expansion into eastern Boulder County. The services offered by the program are different in the western and eastern portions of the county. Since this RFP is for Wildfire Mitigation Specialists, the following background information focuses on the services provided by the specialists. Western Boulder County Programs

Homeowners, with the assistance from Wildfire Partners, work to better protect their homes by actively creating and maintaining a home ignition zone with low ignition potential. Homeowners apply to join the individual home assessment program. Applications that meet all program criteria are accepted into the program as funding and mitigation specialists are available. Over 3,500 homeowners from the western county are currently in the home assessment program. Participants receive:

- A comprehensive, on-site, wildfire home assessment with a Wildfire Mitigation Specialist
- A Wildfire Partners Assessment Report that identifies the weak links in a home's defenses and specific mitigation measures to be undertaken
- Wildfire Partners Financial Awards
- Free access to Wildfire Partners Phone Advisors
- Follow up visits and inspections with a Wildfire Mitigation Specialist
- For qualifying homeowners who pass their inspections, a Wildfire Partners Certificate, yard sign and letter stating that they have performed mitigation

Homeowners are required to actively participate in their home assessments so that they learn the principles and science behind wildfire mitigation. Homeowners provide essential input to the Wildfire Mitigation Specialists as they mark vegetation for removal as part of the program. The specialists use an iPad assessment app to gather information, take photographs and evaluate 50 mitigation related questions grouped into 10 different categories (i.e., roofs, decks, zone 1, emergency preparedness). Following the assessment, the homeowner receives a customized report containing a Mitigation Checklist with their photos of items requiring mitigation. Wildfire phone advisors, along with the mitigation specialists, help homeowners navigate their individual steps in the process.

Eastern Boulder County Programs

Public awareness, education and community mitigation are the starting point for mitigation in high-density, eastern Boulder County. Community liaisons, rather than individual homeowners, submit applications to join Wildfire Partners Community Mitigation Planning program. The technical assistance provide for this program includes community education, community assessments, community action planning, and project identification and implementation. Individual homeowner assessments are conducted in some locations in eastern Boulder County, but no certificates are awarded.

County-wide Programs

Wildfire Partners public awareness campaign, Wildfire Happens Here, was launched in 2024. In addition, Wildfire Partners works with realtors, landscape professions, and youth corps mitigation crews. Wildfire Partners also provides rebates, free community chipping services, and Strategic Fuels Mitigation Grants to residents and organizations.

All questions must be received on or before the Deadline for Submission of Clarifications, as specified in the Schedule of Events. Boulder County will not accept any respondent's communications by any other means, except as specifically stated in this proposal.

### Addendum:

At any time prior to the Close Date, Boulder County may alter, clarify, amend, delete or add to, in whole or in part, any terms or provisions of this proposal.

In order to afford the Bidders a reasonable time for taking into account a material amendment (the materiality of which Boulder County in its own discretion may determine) or for any other reason, Boulder County may, at its own discretion, extend the Close Date.
