In 2017, the State Engineers Office of Dam Safety increased the hazard classification of the dam from Low Hazard to Significant Hazard, meaning there is a significant risk to downstream life and property.

FEMA Hazard Mitigation Grant Program (HMGP) is funding 75% of this project, our 2026 match is \$251,259 to complete this project.

#### POS-126/OS51-Howell Ditch Diversion Design



#### Proposal: \$300,000 1X Operating

BOCC Priority: Climate Action and Environmental Stewardship

This project is a continuation of creek restoration efforts on county open space on Boulder Creek being implemented in partnership with Mile High Flood District.

The project is located immediately downstream of the U.S. Army Corps of Engineer's Lower Boulder Creek project, a project with similar objectives for the creek. This project stabilizes about ½-mile of flood-impacted creek by incorporating Natural Channel Design concepts.

We have a grant from Colorado Water Conservation Board (CWCB) & FEMA flood Total grant revenue anticipated is \$680,000. This \$300K request is for our match.

#### POS-126/OS51-Prairie Run



#### Proposal: \$534,000 1X Operating

BOCC Priority: Climate Action and Environmental Stewardship and Economic Security and Social Stability.

This capital project will span 7 years from 2024 -2030. Total project cost is \$7,300,000. Engineering and permitting has started and will continue through 2026. Construction will occur in two phases starting in 2025 and concluding in 2030.

In 2026 we'll be improving wetland and riparian areas along Lower Boulder Creek from west of Highway 287 to N. 109th St.

Wildlife monitoring will be done for baseline data, and continued during, and after constructing park/trails.

We'll also implement soil health practices, off-stream cattle water, and build storage off-site. Design, construction materials, operational & personnel expenses total \$534,000 million for FY 2026.
