Connecting people and place: A day with Boulder County rangers



Rangers Sarah Andrews and Juan Ocampo hit the trails on their bikes.

Rangers work across trails, programs, and patrols to help residents enjoy open space responsibly.

There's no such thing as a typical day on the job for Boulder County resident rangers Sarah Andrews and Juan Ocampo, and that's part of what they love about it.

For Andrews, a resident ranger at Caribou Ranch Open Space, each shift can look completely different. One day might start with a patrol through the mountains and end out on the plains, checking trails, responding to calls, and helping visitors navigate the space. Along the way, she also juggles meetings, volunteer coordination, and youth programs, work that often happens behind the scenes.

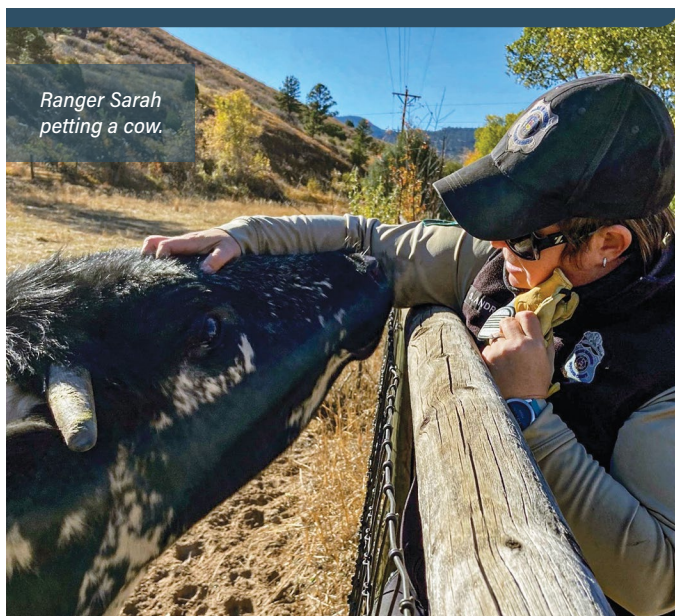
After 23 years on the job, she says one of the greatest rewards has been raising her two kids out in the open space and watching them grow up surrounded by nature.

Ocampo lives at Betasso Preserve and prefers patrols on a mountain bike, where he can access hard-to-reach places faster and farther than he can on foot. In addition to responding to everything from medical assists to trail questions, he also helps lead Las Aventuras de San Lázaro, a program connecting Latinx families with Boulder County open space.

"Every day I've just been feeling grateful to be at work, happy and satisfied at the end of my shift," Ocampo said. "It's the variety and the people that make it meaningful."

Both rangers say the key is connection: talking with visitors, sharing the land, and protecting it together. And while no two days are alike, they agree the best part is simply being out in Boulder County's stunning and ever-changing landscapes.

When every minute matters, these dogs deliver

Highly trained K-9 teams help Boulder County locate missing people and bring critical answers to families — in record time.

When someone goes missing, timing is critical, and in Boulder County, the fastest responders have four legs.

Search-and-rescue dogs like Dottie and Watson, are highly trained to locate missing people or detect human remains, often succeeding where technology falls short. Both dogs were trained for years alongside their handlers, building the focus, resilience, and confidence needed to work in challenging environments.

Dottie, handled by park ranger Kevin Grady, nearly didn't make it to the field. After breaking her neck as a puppy, she underwent surgery and extensive rehabilitation before returning to training. Today, she's fully certified and already proving her capabilities. "On our first mission near Jamestown, as part of a K-9 team of four, we assisted in locating a missing man. Drones

had searched the area for two hours. Within six and a half minutes, our K-9 team found him," Grady said.

Watson, a 3-year-old bloodhound handled by Sheriff's Deputy Josh Scrudder, specializes in tracking and trailing. In one case, he followed a missing man's scent for more than a mile, ultimately leading searchers to the exact spot where the man had been picked up by an ambulance.

These dogs are often trained for 20 or more hours a month and must pass rigorous certifications to operate in the field. Beyond search and rescue, they also connect with the community through school visits and outreach.

For their handlers, one thing is clear: These dogs aren't just impressive. They're essential. Scrudder said, "They're not just working dogs — they're partners."

Growing shade for a hotter future

A tree-planting program focused on heat-vulnerable areas pairs new plantings with ongoing care to help trees survive in a warming climate.

On a hot summer day in Boulder County, a young tree may not offer much shade yet, but it signals a long-term strategy for how communities adapt to a warming climate.

Through a program called Growing Shade, Boulder County and its partners are planting and caring for trees in neighborhoods most vulnerable to extreme heat and environmental stress.

The effort prioritizes disproportionately impacted communities, where there are fewer shady trees, and pavement and asphalt intensify the urban heat effect. The goals are threefold: expand tree cover, reduce climate impacts like extreme heat and poor air quality, and build long-term stewardship so trees survive beyond planting day.

In 2025, Growing Shade planted 95 trees in Longmont neighborhoods. In 2026, Growing shade launched in Lafayette, including manufactured home communities, where 80 trees and 20 shrubs were planted. 150 more trees are planned for Longmont.

Natural Climate Solutions Specialist Dede Croissant said the program was designed to reflect the realities of a changing climate. “Getting new trees to establish and survive in our semi-arid climate has always been a challenge. As our climate becomes hotter and drier, it will only become more difficult,” she said. “That’s why we’re not just planting trees, we’re supporting them through every stage so they can actually thrive.”

That follow-through now includes watering guidance, tools, workshops, and seasonal check-ins to help residents keep new trees alive in a hotter, drier climate.

“The Growing Shade Longmont program is much more than a tree giveaway,” said Longmont City Forester Brett Stadsvold. “It is the model required to build tree canopy on private property in disproportionately impacted neighborhoods.”

For Boulder County, each tree is both simple and strategic: Plant today, improve resilience for decades to come.

25 years of recycling, education, and impact

| Behind the scenes of Boulder County's recycling success.

The Boulder County Recycling Center is celebrating its 25th anniversary, marking a quarter-century as the state's only recycling facility that provides education.

One of its biggest accomplishments is maintaining a residue rate of just 13%, meaning about 87% of what comes through the facility is successfully sorted and returned to circulation rather than landfilled. That level of performance ranks among the best in the country and reflects Boulder County's 40% diversion away from landfill rate, well above the state average.

Education is at the heart of the center's impact. Through guided and self-guided tours operated in partnership with Eco-Cycle, visitors get a behind-the-scenes look at how recycling really works. Kids often leave excited about what they've learned and bring that knowledge home, helping entire families recycle more accurately and confidently.

Looking ahead, Colorado's Extended Producer



Responsibility program will further strengthen recycling in Boulder County by improving consistency and shifting costs to producers.

Climate lawsuit reaches U.S. Supreme Court

| Justices will weigh fossil fuel accountability for climate-driven harms.

Boulder County and the City of Boulder are pursuing a climate accountability lawsuit seeking to ensure fossil fuel companies pay their fair share for climate-driven harms affecting local communities. The case centers on this question:



Who should bear the rising costs of climate impacts on Colorado?

As Susie Strife, director of Sustainability, Climate Action & Resilience, explains, "Our goal is to make sure that fossil fuel companies pay for their share. Right now, families and taxpayers are paying the price for the climate impacts we are facing, but they shouldn't shoulder the burden of these costs alone."

The lawsuit is not about regulating emissions or stopping fossil fuel production, but about seeking accountability for climate-related damages. Strife notes that Colo-

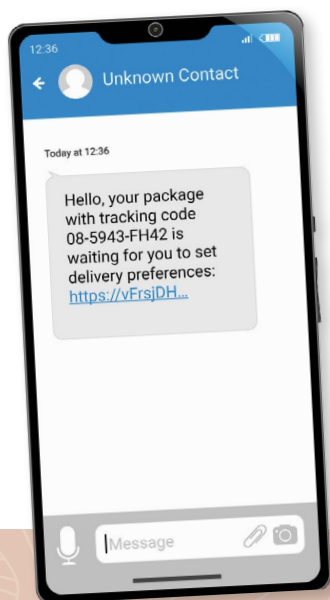
rado is already experiencing more extreme heat, wildfires, drought, and poor air quality, all of which create significant public costs.

Since 2018, the lawsuit against ExxonMobil and Suncor has survived repeated attempts by the companies to move or dismiss it, clearing both a district court and the Colorado Supreme Court. Now the fossil fuel companies are asking the U.S. Supreme Court to intervene. The outcome, expected later this year, carries local and national implications for climate accountability.

Scams are getting smarter. Here's how to spot them.

The Boulder County District Attorney's Office outlines the most common forms of fraud and the warning signs everyone should know.



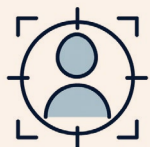
Fraud reports are increasing across Boulder County, with most cases involving "imposter scams," according to the District Attorney's Office. In these schemes, scammers pose as trusted entities, such as government agencies, businesses, or even celebrities, to pressure people into sharing personal information or sending money.

"These scams are most commonly experienced through text mes-

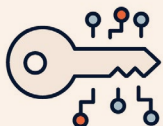
sages, emails, and messaging apps," Desiree Firle from the DA's Office explained. One recurring example is the "jury duty scam," where callers impersonate law enforcement and claim a warrant has been issued unless a fee is paid immediately.

Another common scam mimics companies like tech support services, warning victims they will be charged unless they call back. These scams lead to requests for credit card numbers, gift

Red flags for fraud:



Unexpected contact from someone claiming urgency or authority



Requests for immediate payment or personal information



Pressure to stay on the phone or avoid speaking to others



Demands for gift cards, wire transfers, or cryptocurrency



Threats of arrest, deportation, or account closure

cards, or cryptocurrency payments.

Scammers often exploit stress and isolation. Romance scams can last months or even years, building emotional trust while repeatedly requesting money.

"If someone isn't sure, the first thing they should do is pause," said Firle, community protection specialist. "Step back, slow down, and talk to someone you trust."

Residents are encouraged to verify concerns with family, friends, or the Community Protection Division at 303-441-3700. The office also helps residents report fraud and offers free community education sessions on scams, including emerging threats like AI-generated fraud.

Motor vehicle fraud: What to watch for

Motor vehicle fraud is on the rise in Colorado and nationwide. Scammers continue to refine their tactics, making it increasingly difficult for the public to protect themselves. The Clerk & Recorder's office is committed to helping you stay informed and protect yourself against common types of motor vehicle fraud, such as:

- Title fraud/skipped titles
- Odometer tampering
- Fake dealership or government websites
- Emissions-related fraud
- Document and license plate theft

Whether you are buying or selling a vehicle, there are safety steps we recommend that can make a big difference. Nourishing new life, one box at a time

A Boulder County Public Health program delivers fresh produce to pregnant and post-partum patients, helping close critical gaps in prenatal nutrition.

Pregnancy can already feel overwhelming, and when finances are tight, something as important as eating well can become another source of stress. In Boulder County, a new program is working to take that pressure off.

The Prenatal Produce Rx Home Delivery program helps expectant and postpartum mothers access nutritious, locally grown food by delivering it right to their doors. Through a USDA grant and a partnership between Boulder County Public Health, Adams County Health Department, and Clinica Family Health & Wellness, eligible Medicaid patients receive biweekly boxes of fresh fruits and vegetables valued at about \$50 each.

Boulder County Public Health Healthy Food Access Coordinator Jill Strange said the need became clear through early surveys that showed major gaps in prenatal nutrition, with only about 7% of pregnant patients meeting the recommended intake of fruits and vegetables.

“Prenatal nutrition really impacts everything — from a baby’s development to language and long-term health outcomes,” said Strange. “We knew we needed something direct to help.”

The program, which as of spring 2026 supports 139 enrolled participants, was shaped with input from a patient advisory board of Medicaid-enrolled mothers who helped design box themes and materials.

For participants, the impact is deeply personal. One shared, “This program has helped me a great deal ... everything arrives fresh and in excellent condition, delivered right to my doorstep.” Another said her children “love everything inside the delivery boxes.”

Clinicians say the program is especially meaningful for patients managing conditions like gestational diabetes. As one case manager noted, patients often feel immediate relief, able to cook without fear and focus on their health and their babies.

The program currently continues through six months postpartum, offering support during a critical time of recovery and growth.

The Health Coverage Enrollment Center has you covered

As premiums rise and eligibility rules change, local guides help residents stay insured.

The Boulder County Health Coverage Enrollment Center is helping residents navigate a wave of changes that are making health insurance more complicated and costly.

The center helps people find coverage at no cost through programs like Connect for Health Colorado (the state's health insurance marketplace), Health First Colorado (Medicaid), Child Health Plan *Plus* (CHP+), and Cover All Coloradans. This year, enhanced federal tax credits have expired, and fewer people qualify for financial help. That means monthly premiums for Connect for Health Colorado plans have gone up significantly for many residents, leading to confusion and, in some cases, canceled coverage.

Chandler Budlong-Springer, program coordinator for the Enrollment Center, emphasized the human side of the work. "When people are trying to figure out how to stay covered, what they're really doing is trying to protect their health and their family's stability," she said.

To meet these challenges, the Enrollment Center helps residents compare plans, understand new requirements, and find financial assistance. Most of the team's work centers on helping people navigate the Connect for Health Colorado marketplace to find the best plan for their needs. After subsidies, average monthly premiums in Boulder County are about \$209 compared to more than \$660 at full cost.

The Enrollment Center also works with people to understand their current coverage or to find coverage after major life events,



such as a divorce, birth, or job loss, throughout the year. Staff take a proactive approach as well, focusing on bilingual and bicultural outreach, particularly for Spanish-speaking communities, to build long-term trust and make sure no one falls through the cracks.

"A lot of people don't know what they qualify for or that help is available," says Budlong-Springer. "That's what our Health Coverage Guides are here for. We sit down with you, walk through your options, and help you find the best fit."

Volunteer advocates in the Victim/Witness Unit guide victims of crime through difficult and often overwhelming experiences. Speaking about the work, team member Melinda Kassen shared that "volunteering with the Victim Witness Unit means guiding people through one of the hardest moments of their lives ... so no one has to face the justice process alone or without compassion and care."

4 Miles of Smiles Volunteers – Housing Services **Honored Team: Blake Cambey, Cindy Kellogg, Joel Gilbert, Kelly Reynolds, Mary Pierce, Maureen Handwerker**

Miles of Smiles volunteers pilot trishaw bicycles that bring older adults outdoors to enjoy fresh air, conversation, and Boulder County's scenic open spaces. Describing the program's impact, team member Mary Pierce reflected that "Miles of Smiles gives older adults the chance to feel the wind in their hair again ... bringing people out of isolation and into nature, one ride, one story, and one shared experience at a time."

5 Volunteer Naturalists – Parks & Open Space **Honoree: Dave Fletcher**

Volunteer Naturalists design and lead interpretive programs that help residents understand and appreciate Boulder County's natural history. Dave described his motivation by saying, "I bring Boulder County's landscapes to life ... sparking curiosity, sharing knowledge, and inspiring stewardship."

6 Volunteer Ranger Corps – Parks & Open Space **Honoree: Grant Tietje**

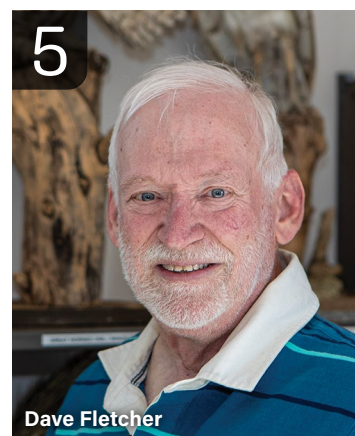
Volunteer Rangers provide a friendly and informative presence on county trails, supporting visitor safety, stewardship, and responsible use of open space. Reflecting on the role of volunteers, Grant Tietje noted that "park volunteers help protect and enhance our open spaces ... ensuring they remain safe, welcoming, and sustainable for everyone, now and for generations to come."

7 Colorado Master Gardeners – CSU Extension **Honoree: Petrea Mah**

Colorado Master Gardeners support horticultural education through hands-on garden care, plant health assistance, and community outreach. Petrea described the heart of the program this way: "The Master Gardener program is about education and outreach ... connecting people with knowledge that supports their land."

Finding home, again

How coordinated care cut veteran homelessness in the county by 50%.

Karl, a Marine veteran, and Linda had lost their home, belongings, and stability. When they connected with Boulder County partners and Veterans Community Project (VCP) Longmont Village, they were living

in a motel, racing against the expiration of a housing voucher, and trying to navigate a complex system while managing Linda's serious health needs.

Through coordinated support from VCP, local case managers, and the U.S. Department of Housing and Urban Development-Veterans Affairs Supportive Housing (HUD-VASH) program, they moved into VCP's bridge housing, a temporary housing option for voucher holders while they find a permanent apartment.

Staff then worked with Veterans Affairs (VA) partners to secure permanent housing while supporting Linda's

medical and mobility needs.

Karl and Linda's outcome is no accident. Boulder County has reduced veteran homelessness by 50% over the past year.

"It's about making sure partners are connected and bringing their expertise to the table," said Heidi Grove, who oversees the division of homeless systems and coordinated response. For families like Karl and Linda, that connection makes all the difference.

After 30 years on the street, a Boulder resident finds home

Sue's journey highlights the impact of coordinated, supportive services.

After more than 30 years of experiencing homelessness, Sue, a lifelong resident of Boulder, was able to move into stable housing. Sue has struggled with severe mental health challenges and a tragic past of victimization and trauma. Her being in a stable home is a victory for her and her champions at All Roads. While All Roads provided interventions that led to stable housing 211 times in 2025, Sue's home-finding is especially meaningful for staff.

All Roads is a housing-focused nonprofit that ends homelessness through unrelenting compassion,

innovation, expertise, and collaboration, leveraging resources to effect as many permanent exits from homelessness as possible while also attending to the urgent needs of the homeless. All Roads receives annual funding from Boulder County.

Flexible funding for affordable housing

How Lilac Place got a major upgrade with the help of the housing tax.



Lilac Place, a 12-unit affordable housing community in Louisville, has served local families since 1970. Owned and managed by the Boulder County Housing Authority (BCHA), the property offers stable two-bedroom, one-bath homes for households earning about 60% of the Area Median Income, helping

seniors, workers, and families remain in the community.

To preserve affordability and extend the life of the property, BCHA recently completed a major rehabilitation of Lilac Place, addressing aging infrastructure, improving energy efficiency, and upgrading safety features while modernizing interiors and outdoor spaces.

The renovation was funded through a combination of Boulder County Sustainability dollars, Energy Outreach Colorado investments, and Affordable and Attainable Housing Tax (AAHT) funding, which helped close critical financing gaps. Without it, officials said, improvements likely would have been delayed or completed in phases.

Upgrades included new plumbing and electrical systems, energy-efficient heating and cooling, updated flooring and cabinetry, and exterior improvements such as siding, windows, exterior doors, fencing, xeriscaping, patios, and drainage and driveway work.

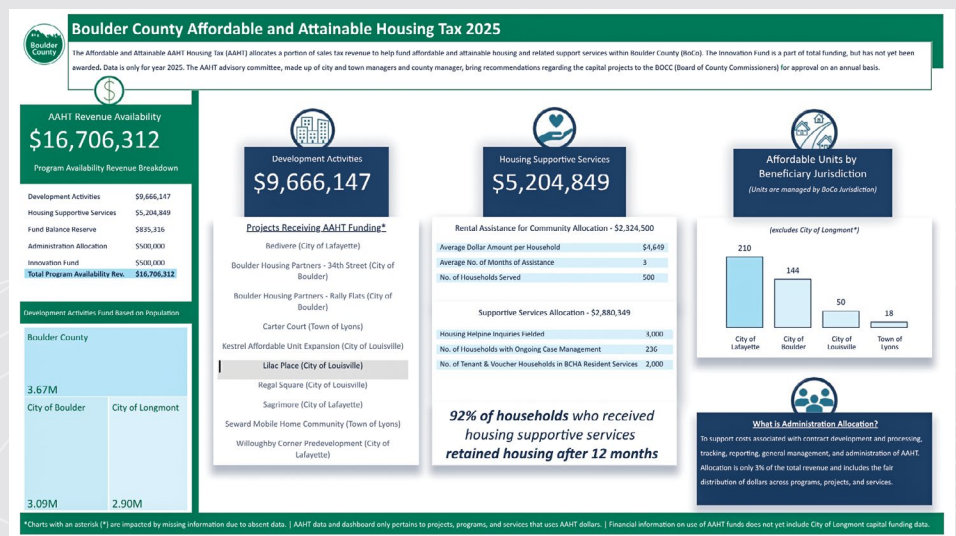
“Lilac Place stands as an example of how targeted investments and community-driven funding tools like AAHT can safeguard vital housing resources,” said Michelle Alexander, deputy director of housing.

As Boulder County continues to face rising housing costs, the project highlights how strategic local investment can preserve affordable housing, prevent displacement, and help residents remain rooted in their communities.

Here to listen, here to help

| CAT and WellMind are here for your mental health.

Every day, the Community Assistance Treatment (CAT) and WellMind serve as a lifeline for Boulder County residents. Together, they provide a centralized mental health response, separate from the police, for residents who need emotional support, crisis guidance, or help navigating the system.

CAT focuses on in-person community assistance, while WellMind connects residents by phone or in person to the support they need.

WellMind's call center fields a wide range of concerns, from sup-

port for children with behavioral or school challenges to elderly residents seeking connection and guidance to combat loneliness. Fully bilingual staff ensure support is accessible to all.

Last year, a man who'd recently experienced a traumatic event reached out to WellMind. Though he had resisted therapy due to stigma, his trauma was affecting his daily life. In just a few meetings, he began sleeping better, felt more at ease, and even encouraged his wife to seek support.

"Sometimes, you just need a nonjudgmental space," said Jes-



sica Jaramillo, program manager and clinical supervisor. "We're here to help you navigate life a little better."

| Boulder County focuses on kinship care

When children can't remain with their parents, Boulder County turns to kinship care, a simple but powerful solution linked to lower trauma, stronger emotional outcomes, and greater stability. This solution prioritizes keeping children with relatives

or trusted adults.

"As much as possible, we want kids to be with family or familiar caregivers," says Suzanne Daniels of Boulder County's Family and Children Services. "When you're going through something traumatic, being with someone you know and trust makes a profound difference."

In 2025, roughly 59% of Boulder County children in out-of-home care were placed with kin. Daniels credits this to intensive family-finding efforts and expanded support systems for caregivers.

Unlike traditional foster parents, kinship caregivers aren't often prepared for the sudden addition of children, so the county provides hands-on support,

like crisis management, and resources, like beds and car seats. Staff also help families become certified foster providers, opening the door to stipends and additional services.

Beyond logistics, the program fosters connection. Community events bring kinship families together, helping caregivers and children build support networks and reminding them they're not alone.

"We meet families at some of the hardest moments in their lives," Daniels says. "To witness their resilience and be able to support them through such challenging times is incredibly important to us."

Building a safety net that lifts us all

Behind all strong communities are the people and programs working to make sure no one gets left behind. In 2026, Boulder County Human Services is funding 28 local organizations through the Community Partnership Grant to improve health, well-being, and access to services. Meet three of them.

OUR Center

In 2020, nearly 11% of Boulder County residents, including more than 3,000 families, were living below the poverty line. For many of those families, the Outreach United Resource (OUR) Center is the first place they turn.

Based in Longmont, the OUR Center serves low-income residents across surrounding communities, including Lyons, Niwot, Hygiene, and Allenspark. With support from the Community Partnership Grant, the organization connects people to healthy food, rent and utility assistance, resource navigation, and programs for all ages.

The OUR Center expects to serve more than 20,000 people through its programs, helping families stabilize and stay connected to the support they need.

El Centro Amistad

Since 2001, El Centro Amistad has worked to promote equity in health, education, and quality of life for the Latino community in Boulder County.

With funding from the Community Partnership Grant, El Centro Amistad relies on trusted community health workers known as “Promotoras” to share information, offer support, and help people navigate the health system. Their bilingual, culturally grounded programs focus on healthy living, nutrition, and mental health.

The grant also supports the annual Compañeras Summit, the only event in Boulder County focused on Latina women and girls, promoting cultural pride, health, education, and leadership.

Last year, El Centro Amistad reached nearly 3,000 people across these efforts and aims to grow that number in 2026.

Clinica Family Health and Wellness

Many people in Boulder County already struggle to get the health care they need. Now, new federal rules are expected to leave thousands more without coverage.

Clinica Family Health and Wellness is the region’s largest safety-net provider, offering medical, behavioral health, and dental care, along with prevention and community-based services. The organization serves people who face barriers to care, regardless of their ability to pay. Formed in 2024 when Clinica Family Health and Mental Health Partners merged, it brings more than 100 years of combined experience to the community.

With two Community Partnership Grant awards, Clinica expects to serve more than 250,000 people this year, connecting residents to care that helps improve their overall health and well-being.

Building resilient forests in a changing climate

| As wildfire risk grows, Boulder County takes a proactive approach.

Forest thinning is often used as shorthand for forest management. In Boulder County, it's just one piece of a much bigger strategy.

According to Forest Planning Supervisor Shane Milne, local forest work blends wildfire mitigation, ecological restoration, and long-term resilience. "It's not simply removing trees," he said. "Each project is shaped by the landscape, forest type, and goals for that area."

That nuance matters. Lower-elevation ponderosa pine forests, for example, are far denser today than they were historically, largely due to decades of fire suppression. In those areas, crews work to restore a more natural pattern of tree clusters interspersed with open space, mimicking the effects of frequent, low-intensity fires that once shaped the ecosystem.

Higher elevations tell a different story. There, forests are naturally denser and more diverse, and management focuses on reducing stress from overcrowding, insects, and disease while increasing species and age diversity.

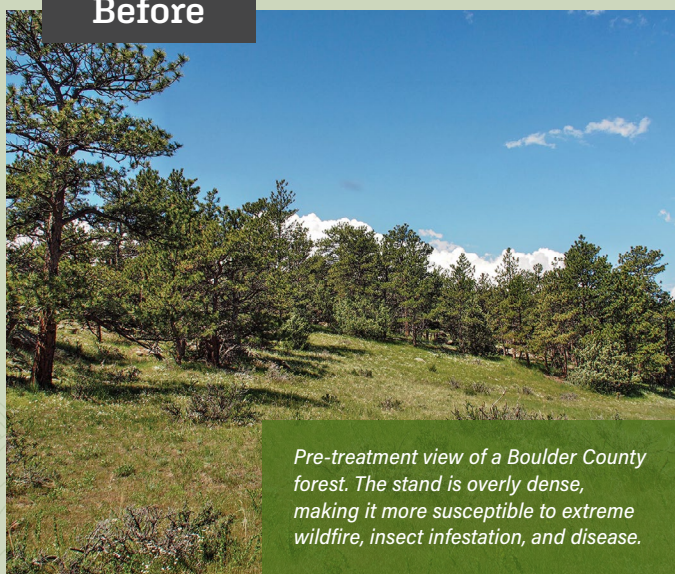
Across all elevations, the goal is the same: resilience. Thinning helps remove potential fuel for wildfires while giving remaining trees more access to light, water, and nutrients. In turn, the trees are better equipped to withstand drought and pests.

That work is increasingly urgent. Hotter, drier conditions are fueling larger, more intense wildfires, while more residents are living in fire-prone areas. "In this wildland urban interface, we can't simply let nature take its course anymore," Milne said. "We have a responsibility to actively manage these lands to reduce risk, protect our communities, and preserve our forests."

And despite common assumptions, the work isn't profit-driven. "We actually pay to remove trees," he notes. "This is about forest health and public safety."

Reducing wildfire risk, together

Cash rebates for performing wildfire mitigation are available to multi-family communities.

In many Boulder County neighborhoods, wildfire risk can come down to what's planted just a few feet from home. But for residents in apartments, condos, and HOA communities, taking action in shared common-space areas hasn't always been straightforward.

After launching a general wildfire mitigation rebate program in 2024, county staff heard from many multi-family residents who wanted to participate but couldn't due to shared property structures. Those requests led to the addition of multi-family communities to participate in the juniper removal program, Junk Your Junipers.

The program offers rebates to remove junipers, a common landscaping plant that's highly flammable and can act "like gasoline" in a fire, sending embers

toward nearby homes.

"Junipers were widely planted because they're hardy and low-cost, but they can pose a real risk when they're close to homes," said Jeff Stanley with Boulder County's Wildfire Partners program.

Launched as a pilot in 2025, the program quickly exceeded expectations. In just 2.5 months, 43 communities participated, representing more than 6,000 homes. Crews removed more than 3,000 junipers, with nearly \$502,000 in rebates distributed.

By focusing on entire communities, the program makes it easier for neighbors to take action together and reduce wildfire risk at scale.

Know before you ride

E-bikes and electric vehicles aren't all equal under Boulder County law.

As e-bikes and other two-wheel electric vehicles become more common in Boulder County, officials say confusion over what's legal and safe is leading to preventable crashes and community concerns.

E-bikes provide riders with a speed boost through an electric motor of 750 watts or less. Support from these motors helps riders ride farther, up steeper inclines, and with heavier loads. E-bikes are generally classified based on their maximum speed and how they give you power. Depending on the type of e-bike you use, different rules apply.

Two wheels and electric power don't equal an e-bike

Law enforcement reports increasing confusion between Class 1–3 e-bikes, e-dirt bikes, e-motorcycles, low-power scooters, and toy or modified electric vehicles. "One of the biggest challenges is

education for both parents and kids," said Boulder County Sheriff Sergeant David Salaman. "People assume if it's electric, it can go anywhere, but that's not the case."

Officials emphasize that choosing the right device matters for both safety and legality:

- **Class 1 and 2 e-bikes** are generally allowed on bike paths and some trails.
- **Class 3 e-bikes** are restricted from Boulder County Open Space trails but are permitted on bikeways like the US 36 Bikeway.
- **E-dirt bikes and e-motorcycles** are classified as motorized vehicles and require a motorcycle endorsement, registration, license plates, and insurance when used on public roads. They are not permitted on sidewalks or multi-use trails.
- **Low-power scooters** may require registration and insurance, depending on use.

- **Toy vehicles**, which have wheels but aren't designed for street/off-road use, are not permitted on any public county roads or trails.

Safety guidance for traditional bikes also applies to e-bikes, including wearing helmets, using lights, and riding predictably, especially given their faster acceleration and heavier weight. Note that modifying electric bikes/vehicles to increase speed is potentially illegal.

E-bike buyers should look for products that meet UL 2849, the Standard for Electrical Systems for e-bikes, which covers electrical and fire safety.

Remember: If your child isn't yet safe on a regular bike, they're not ready for an e-bike.

Powering the future in Boulder County

Power Ahead Colorado will transform home comfort in Colorado and train thousands of workers on efficient, electric technologies.

A new regional program is helping residents make their homes more comfortable, healthier, and more efficient, while also bringing clean energy training and jobs to Boulder County.

Power Ahead Colorado, led by the Denver Regional Council of Governments, helps people make their buildings more efficient and ready for the future, starting with modern electric technologies like heat pumps. The program aims to help make these upgrades to homes and businesses as easy as possible by connecting Coloradans to the clear information, trusted guidance, financial incentives, and qualified contractors they need, all in one place. Some low-income households may qualify for more extensive support that covers the cost of major upgrades.

"It's really about creating a regional one-stop shop so people can get guidance, incentives, and trusted contractors all in one place," said Zac Swank, deputy director of Boulder County's Office of Sustainability, Climate Action, and Resilience.



In addition to resources for home and business owners, the program will also support training for nearly 5,000 workers across the region, including opportunities for existing contractors to upskill and for new workers to enter the field through targeted programs for youth, Spanish speakers, and other communities. Workforce centers across the Denver Metro area, including Workforce Boulder County, will play a key role in this training effort.

Power Ahead Colorado is funded by a nearly \$200 million federal grant. Boulder County played a key role in securing the grant funding for Power Ahead Colorado, which was inspired by programs like EnergySmart and Partners for a Clean Environment.

How Boulder County verifies every vote

Multiple safeguards and public transparency ensure secure elections.

In Boulder County, security and transparency are built into every step of the voting process, with safeguards designed to ensure every ballot is accurately counted and verifiable.

"Election security is fundamental to maintaining trust," said Clerk and Recorder Molly Fitzpatrick. "Our community deserves absolute confidence that every ballot is protected and counted accurately."

Colorado's mail-based system uses paper ballots and includes multiple layers of security, including pre-election testing of ballots and the voting system, bipartisan signature verification and ballot processing teams, voter ballot tracking, and post-election audits.

The voting system is not connected to the internet, and drop boxes are monitored by security cameras. These safeguards are the standard across Colorado and balance security with accessibility.

Residents are also encouraged to participate directly in the process. Boulder County hires hundreds of local election judges each cycle and offers public ballot processing tours, observation opportunities, and online security resources to address frequently asked questions.

"I wish every voter knew how many checks, audits, and people are involved at every step," Fitzpatrick said. "Nothing in our process depends on trust alone."

Keeping Boulder County's signalized intersections safe and reliable

A new contract with Lighthouse Transportation Group strengthens traffic signal response while advancing equitable procurement goals.

When a traffic signal is damaged, it can quickly turn a routine intersection into a safety hazard. That's why Boulder County's new partnership with Lighthouse Transportation Group, a certified minority- and women-owned business enterprise, focuses on keeping signal systems running and restoring them quickly when they fail.

The contract includes 24/7 response to signal outages, routine maintenance, and system upgrades, such as replacing aging poles and improving intersection technology across the county. It is expected to support safer, more reliable travel for drivers, cyclists, pedestrians, and emergency responders.

"Traffic signals are a critical part of our transportation system," said county traffic engineer Mark Shisler. "If a signal is damaged or malfunctioning, the consequences can be serious. Having a responsive partner ensures we can act quickly to restore safety."

Shisler said Lighthouse stood out for its tech-

nical expertise and collaborative, partnership-focused approach.

The contract also reflects Boulder County's updated equitable procurement policy, which is designed to expand access for minority- and women-owned businesses while maintaining a competitive selection process. The county gets more bidders through increased outreach, which increases competition and choice.

"The update reflects a shift from simply posting opportunities to more intentionally ensuring those opportunities are visible and accessible," said procurement specialist Karina Jensen. "By improving visibility, simplifying access points, and requiring proactive outreach, the county is working to create a more equitable and inclusive procurement environment."

The road forward

How this summer's road projects will pave the way for a better-flowing future.

For many Boulder County drivers, road construction isn't something they read about. It's something they sit in.

This summer, that reality continues along 120th Avenue from Overlook Drive to Dillon Road, where years of overlapping construction between Boulder County, the City of Lafayette, and local developers are finally nearing completion. When finished, the project is expected to bring long-awaited relief to daily commuters who have spent years navigating delays in the corridor.

"When it's finished, it will close out a long chapter for people who travel that route every day," said Steve Durian, director

of Boulder County Public Works.

While large roadway projects tend to draw attention, Durian said much of the department's work happens behind the scenes — repairing bridges, maintaining drainage systems, and addressing the "plumbing" that keeps roads safe and functional. This season's work includes culvert repairs on 119th Street, bridge reconstruction at Baseline Road and Dry Creek, and multiple resurfacing projects aimed at improving daily travel conditions across the county.

With increased funding in the 2026 budget, the county is also expanding maintenance paving on heavily traveled routes like Hurricane Hill Road, Ridge Road, and Overland Road, along with chip seal work on rural roads that many residents rely on for school, work, and emergency access.

Durian said the goal is simple: Keep people moving safely while balancing rising construction costs and long-term maintenance needs.

Beyond roads, Public Works also manages county facilities, including a new Boulder hub at 28th Street and upgrades to emergency services and public buildings.

"We're focused on making sure we can maintain essential services while adapting to increasing costs," Durian said.

While much of the work happens out of sight, its impact is felt every day by commuters navigating Boulder County's growing and changing road network.

When disaster strikes, preparation matters

Boulder County residents share how preparedness workshops helped when it mattered most.

When a wildfire forced Robyn Sloan and her family to evacuate their home near Lyons during the Stone Canyon Fire, they didn't have to start from scratch. Years earlier, they had taken a Boulder Office of Disaster Management preparedness workshop. Those plans made all the difference.

"Using plans from the workshop, we were able to grab a briefcase with financials, go bags with clothes and medicines, and our pets," Sloan said. "Having to think about these things ahead of time made our escape possible."

For others, the impact starts small. After attending a workshop, resident Louise Brooke said she began



by charging a backup battery, organizing emergency supplies, and checking her fire extinguisher.

According to the Boulder Office of Disaster Management, the workshops are designed to meet people wherever they are with preparation. Topics range from emergency alerts to evacuation preparedness and scenario planning.

Property tax relief for Colorado Seniors

Do you qualify for one of these programs?

Boulder County helps administer three main property tax relief programs for older adults, designed to reduce or delay property tax burdens depending on eligibility.

The Senior Property Tax Exemption exempts the first \$100,000 of a qualifying primary residence's value for eligible seniors, surviving spouses, and long-time homeowners who meet residency and age requirements. For the 2026 tax year payable in 2027, applicants must have been born on or before January 1, 1961, and lived in the home continuously since before January 1, 2016.

A second option, the Qualified Senior Primary Residence Classification, provides a temporary tax reduction for seniors who previously qualified for the exemption but no longer do, provided circumstances haven't changed.

Lastly, the Senior Tax Deferral program allows eligible seniors to postpone paying property taxes until the home is sold or the estate is settled, with interest accruing.

Boulder County's budget

Every year, Boulder County works for eight months to figure out how much money it will have to spend in the following year and how to spend that money on services, programs, and projects for county residents.

Through Priority-Based Budgeting (PBB), a strategic approach designed to better align taxpayer resources with community priorities and measurable outcomes, the county is evaluating programs and services to help ensure limited resources are focused on the highest-value services and long-term community needs.

Like many local governments across the country, Boulder County is facing increasing service demands, inflationary pressures, and long-term financial challenges. The budget process helps county leadership make thoughtful, data-informed decisions while maintaining essential public services and planning for the future.

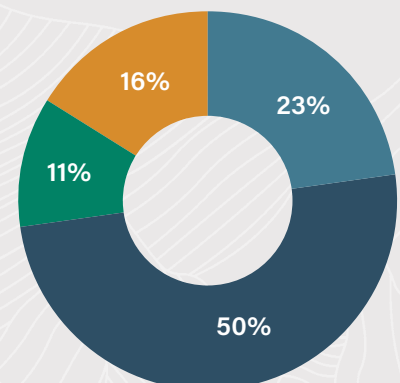

Housing Choice Voucher (HCV) Program

Also known as “Section 8,” this program provides rent subsidies for individuals and families on very low incomes — including the elderly and those with disabilities — in Boulder and Broomfield counties. Participants contribute about 30% of their income toward rent and can choose their own housing. Eligibility applies, and vouchers are distributed through a lottery when available.

Property Tax and Valuations

- The county calculates, collects, and distributes tax on behalf of 135 different taxing entities.
- Every two years, the Assessor's Office is required by the State of Colorado to appraise the value of all residential and commercial properties using an assessment rate set by the state. The next valuations will be sent to property owners in May 2027.
- The Treasurer's Office calculates property taxes based on the assessed value and the mill levies set by the taxing authorities where the property is located (for example, school district, fire district, library district, water district, city, etc.). Tax notices are sent out in January each year.

Voting and Elections

The Elections Division, which is under the office of the Clerk & Recorder, registers voters, maintains voter registration records, and conducts elections for the county. There are typically elections every November on state and/or local issues/candidates and primary elections in June of even years. Additionally, there is a presidential primary in March every four years. A few voter tips:

- Get registered or check your voter registration at GoVoteColorado.gov. Voters must update their voter registration record every time they move.
- In Colorado, eligible voters are automatically mailed ballots for every election beginning about 3 weeks prior to the election. Voters also have the option to vote in person.
- Colorado does not have a registration deadline, and eligible voters can register to vote up to and including Election Day.
- Consider adding an email address to your voter registration record. Emails are considered confidential and not part of the public voter file. An email address helps the election office reach voters if a problem arises with mailing addresses or ballot envelope signatures.

Motor Vehicle and Records

Vehicle Registration

The Motor Vehicle Division, which is under the office of the Clerk & Recorder, titles and registers motor vehicles, issues disability placards, and renews vehicle registrations for Boulder County residents. In recent years, in order to reduce wait times for the public, Boulder County Motor Vehicle moved to an appointments-only system for in-person visits (with exceptions for emergencies). Additionally, annual vehicle registration/license plate renewals need to be completed out of office. Convenient options include online, by mail or drop box, or at a self-service kiosk. 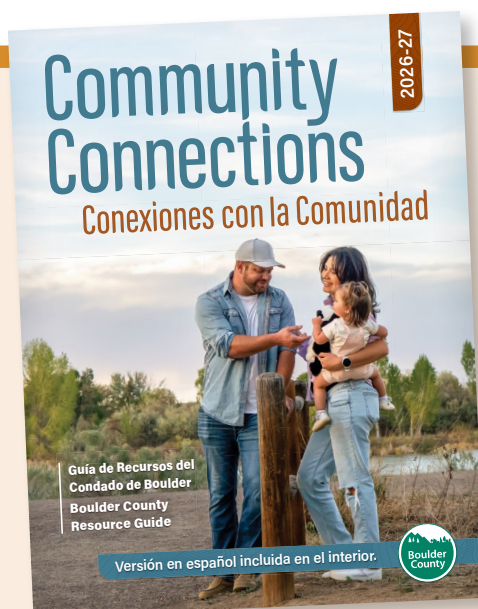
